THE WORLD WILL BE URBAN

Today <u>55% of the world's population lives</u> in cities, yet by 2050 this is expected to increase to 68%



CITIES ARE CENTRAL TO SDGs

SDG 11: Make Cities and Human Settlements Inclusive, Safe, Resilient and Sustainable is closely integrated with the other 16 SDGs.



By investing in SDG 11 we impact on several other SDGs.



PROBLEM:

As the world continues to urbanize there is an urgent need to step up the realization of the transformative potential of cities as a positive force for sustainable development.

FACTORS:

- Not all cities are aware of the SDGs
- Not all cities are incentivized to engage with global agendas
- Not all cities are aware of frameworks such as the NUA to guide them in the local implementation of the SDGs





SDG CITIES THEORY OF CHANGE

SDG Cities Global Initiative aims to be systematic in its support to cities

Using Global Urban Monitoring
Framework (UMF) indicators to collect
and monitor local data to inform city
development strategies

Suggesting areas for institutional capacity strengthening

Increasing the capacity for SDG project development, financing, and implementation

SDG CITIES INITIATIVE

- SDG Cities is a global initiative that encourages cities to catalyze their own potential and accelerate their achievement of the Sustainable Development Goals (SDGs)
- Cities are given tools to assess their baseline data and identify and finance priority initiatives that actively localize the SDGs and improve quality of life with measurable impact.

Data




Strategic Planning

PURPOSE OF SDG CITIES CERTIFICATION:



SDG Cities certification helps set cities on the course to accelerated achievement of the Sustainable Development Goals by:

- 1. Guiding an effective local urban development process, in line with the New Urban Agenda
 - 2. Recognizing the achievement of key milestones and inclusive, effective processes

MILESTONES RECOGNISED BY SDG CITIES CERTIFICATION



- 1. Cities have effective data for social, economic and environmental dimensions with analyzed gaps in urban areas and have evidence-based, inclusive, participatory and strategic development frameworks for 2030 that:
 - Are aligned with the 2030 Agenda;
 - Are aligned with local development priorities;
 - Are coherent with relevant national, subnational, cross-border and sectoral policies and priorities.
- 2. Cities are effective "drivers of change": They have taken stock of their governance, and revenue systems, plans and regulations and assessed the performance of key basic urban services and have demonstrated progress in strengthening them
- 3. Cities are generating measurable SDG impact

IMPLEMENTATION MECHANISM



Technical Reviewers:

Review and validate inputs and supporting evidence- their work will be assisted through the technical capacity of the platform.



Approval:

A certification committee will decide on the issuing of certification based on these reports, undertaking spot checking as necessary.





SDG Cities certification digital platform:

Provides templates and diagnostic tools and enabling a self-assessment process where cities enter data and upload relevant supporting evidence.



Reporting:

Generated for each stage to indicate if criteria have been met and which gaps should be addressed.



Technical Assistance:

Where eligibility is not met, cities are directed to technical assistance services, digital tools, and good practices that can help address gaps.



GLOBAL & NATIONAL MECHANISM



Oversight and certification

NATIONAL CERTIFICATION PROCESS (OPTIONAL):

Alignment of national priorities

When not eligible, cities and local institutions can consult with UN-Habitat and UN partners involved in SDG Cities certification on actions to meet certification requirements.

They will be guided to available open-source technical and capacity development tools to help the bridge gaps.

The platform will include a search engine that identifies relevant tools and case studies, drawing on the NUA Platform and open-source materials of other UN entities and academic partners

- Identify a credible community of UN agencies and stakeholders to further develop the model and implementation modalities
- Jointly deliver the SDG Cities certification model with the credible community of such entities
- Reach out to UN partners, Member States, and other stakeholders for feedback and review
- Engage the Local2030 Coalition to further develop the SDG Cities certification concept and integrate SDG Cities certification into the work of the coalition.
- Further develop the business model and funding strategy and identify funding sources.
