Multi-Level Governance

Multi-level governance is an essential lever across the ten UNHA2 resolutions, and UN-Habitat promotes it as a cross-cutting feature of its Strategic Plan 2020-2025

National Urban Policies are a key prerequisite for the overall enabling of intergovernmental cooperation and coordination, as well as the institutionalization of multi-stakeholder participatory processes.

Sectoral multi-level governance processes play an important role in enhancing the effectiveness of national and global policy initiatives.

→ Effective urban climate action and multilevel climate action is promoted through the *Ministerial Meetings on Urbanization and Climate Change* at the UNFCCC COPs.

Local2030 Coalition



UN System-wide platform and network for supporting and accelerating the localization of the 2030 Agenda for Sustainable Development.



Governance Structure:

- **UN Co-chairs:** 1 permanent (UN-Habitat) and 1 rotational (2022-2023 UNDP and 2024-2025 FAO)
- **UN Directors Group**: 15 UN entities (UN-Habitat, FAO, UNDP, UNICEF, DCO, UNDESA, UNECE, ESCAP, UNEP, UNHCR, IOM, WHO, UN-WOMEN, ILO and UNFPA) with the support of EOSG and the Joint SDG Fund
- Steering Committee members: LRG, LRG association, member state, CSO, the private sector, the host of the Secretariat and Local 2030 Hub
- Local2030 Hubs: 6 active Hubs located in different regions and working on specific themes



Local2030 has effectively galvanized **multilevel and multi-stakeholder** support, driving concerted efforts towards harnessing the **transformative potential of localization** as a catalyst to push for the achievement of the six key SDG transitions – being recognized as the UN **High Impact Initiative on Localization**.

SDG Cities



Goal: Supporting over 1000 cities to accelerate their achievement of the SDGs and positively impacting 1 billion lives by enhancing

- (a) data collection and analysis,
- (b) strategic planning,
- (c) strengthening of local institutions, and
- (d) investment and implementation.



The progress of SDG Cities includes **49 onboarded cities** worldwide, **seven digital tools** and **one digital management system developed with 4 e-learning courses** working on progress for their development.

The SGs Advisory Group on Local and Regional Governments



Called for the establishment of the Advisory Group on LRGs for a reinvigorated multilateralism



Established in October 2023, the Advisory Group is tasked to guide the SG in inclusion of the LRG constituency in the **preparation for the Summit of the Future and its outcome document**, the Pact for the Future.



To ensure the **local and regional governments' dimensions** are reflected in the Summit and the **Pact for the Future**.

To advise the UN Secretary-General on matters pertaining to local and regional governments' engagement and action and to inform Member States' decision-making.



Co-Chairs: National Government of Spain and Regional President of Nouakchott, Mauritania.

Members: 5 national governments, 15 LRG representative, the SG, DSG, USG for Policy, Chef-de-Cabinet, UNH ED







The SGs Advisory Group on Local and Regional Governments



Recommendations of the SG's High-Level Advisory Board on Effective Multilateralism that urges Member States to strengthen multilateralism by harnessing the power of LRGs and fostering multi-level governance guide the work of the AG.



The AG builds on outputs of the **UN Global Task Force on the Future of Cities**, active from 2019-2021.



Consultations with LRG Associations, Member States, the UN system, and civil society groups further inform the inclusive preparation of outputs.
