Hosting of the Eleventh session of the World Urban Forum - in 2022

1. THE WORLD URBAN FORUM

The World Urban Forum (WUF) is the world's premier conference on urban issues. It is a non-legislative technical forum convened by UN-Habitat since 2002.

The Forum has become one of the most open international gatherings for exchanging views and experiences on urban challenges. The inclusive nature of the Forum, combined with high-level participation, makes it a unique United Nations conference and the foremost global arena for interaction among policymakers, local government leaders, non-governmental organizations and expert practitioners in the field of sustainable urban development and human settlements.

The Forum is held in a different host city and country biennially. The participation in the Forum has significantly increased in last years and steadied at around 18,000 participants from all over the world in WUF7 held in Medellin, Colombia, in 2014.

2. THE WORLD URBAN FORUM AND THE NEW URBAN AGENDA

The New Urban Agenda1 was adopted in October 2016 at the United Nations Conference on Housing and Sustainable Urban Development – Habitat III in Quito, Ecuador. It is a result of a unique consensus among all participating states. The document sets out a common vision and global standards for urban development in the coming decades and offers a paradigm shift in the way we think, build, and manage cities.

The New Urban Agenda has come at a critical moment, when for the first time in history over half of the world's population is residing in cities. Cities, if planned and managed well, will become the main tool for sustainable development and have a potential to be a solution to many of the challenges our planet is facing today. The New Urban Agenda lays out the vision for future cities based on the science of urban development providing tools in crucial areas.

CALL FOR EXPRESSION OF INTEREST

In paragraph 167 of the New Urban Agenda, participating States request the report of the implementation of the Agenda to incorporate, to the extent possible, the inputs of multilateral organizations and processes where appropriate, civil society, the private sector and academia and to build on existing platforms and processes such as the World Urban Forum convened by UN-Habitat.

3. THE ELEVENTH SESSION OF THE WORLD URBAN FORUM (WUF11) IN 2022

By 2050, the world's urban population is expected to nearly double, making urbanization one of the twenty-first century's most transformative trends. The World Urban Forum aims to gather participants to discuss and readdress the way cities and human settlements are planned, designed, financed, developed, governed and managed in a city that is globally recognized for its innovation and urban solutions in sustainable development. The Forum will explore ways and provide insights and lesson that will promote and contribute to inclusive development in all parts of the world and the implementation of the New Urban Agenda.

4. OBJECTIVE OF THE FORUM

The World Urban Forum has the following objectives:

- raise awareness of sustainable urbanization among stakeholders and constituencies, including the general public;
- improve the collective knowledge of sustainable urban development through inclusive open debates, sharing of lessons learned and the exchange of best practices and good policies; and
- increase coordination and cooperation between different stakeholders and constituencies for the advancement and implementation of sustainable urbanization
- platform to incorporate the inputs of multilateral organizations and stakeholders into the reporting of the implementation of the New Urban Agenda

The Eleventh session of the World Urban Forum will also contribute to global mobilization towards advocating for the common vision on sustainable urban development and advancing on the achievement of the Agenda 2030 and the Sustainable Development Goals.

5. BID PROCESS AND TIME FRAME

The closing date for receiving of the Expression of Interest for WUF11 is 30 July 2017. The table below outlines the time frame of important dates for the complete bidding process.

6. FINANCIAL CONTRIBUTION

To host the World Urban Forum a financial contribution is required. The host country for WUF11 is expected to make a minimal contribution of eight million US dollars (USD 8,000,000) total cash contribution to UN-Habitat spread over 4 years. Information on the purpose of the cash contribution to UN-Habitat will be provided as part of the bidding proposal.

Additionally, the host country is required to provide an in-kind contribution of: the venue with its conference facilities; services and requirements for registration and accreditation; security services and equipment according to United Nations security regulations within the city, around and within the venue; interpretation services for the main sessions; operational and logistical needs with respective human resources in the country, city and at the venue.

7. EXPRESSION OF INTEREST

A city wishing to express its interest to officially host the Eleventh session of the World Urban Forum (WUF11) is required to send an official communication (on letter head and with signature) to the UN-Habitat WUF Secretariat, addressed to the UN-Habitat Executive Director, Dr. Joan Clos, within the above mentioned deadline to the following email address: **wuf11bid@unhabitat.org**
