The Role of the Real Estate Sector in Planning for Sustainable Urbanization: City Prosperity Initiative to Guide Urban Growth

A representative of the International Real Estate Federation (FIABCI) announced that the organization had signed a letter of intent with UN-Habitat and would support the implementation of enhancements to the Programme's City Prosperity Initiative (CPI) with software developed by FIABCI. The NGO is a partner of the World Urban Campaign and a member of the General Assembly of Partners, holds consultative status with ECOSOC and has participated in various events linked to the Habitat III process.

A representative of UN-Habitat noted that the CPI could help cities guide development in a more balanced, sustainable and prosperous manner. The CPI could help not only decision-makers and city authorities but also the other stakeholders involved in city planning. That was why UN-Habitat wanted to engage civil-society partners.

A representative of the International Society of City and Regional Planners (ISOCARP) expressed support for the CPI, noting that urban monitoring was essential for implementing the New Urban Agenda, and that the CPI offered a reliable urban monitoring framework integrated with a capacity-building tool.

A representative of the World Urban Campaign highlighted the relevance of public-private partnerships for effective implementation of the New Urban Agenda and achievement of Sustainable Development Goal 11.

Key messages of the side event were that, first, there was a need to diversify the CPI and make it available for use with all national urban policies, in line with national regulations, and, second, that the CPI would benefit from the integration of quality indicators and capacity-building of city planners.

A Hub for Housing: Leveraging Multi-Sector Partnerships for Knowledge Exchange

The side event showcased progress in establishing the Urban Housing Practitioners' Hub, a new knowledge management network that had emerged from Habitat III. The Hub is designed to enhance the expertise and increase the number of practitioners in the Latin American and Caribbean region seeking to improve housing conditions for the urban poor. Approximately 45 people attended the event, which focused on:

- Illustrating the “network of networks” approach to creating the Hub, involving more than 60 organizations;
- Presenting the Hub's preliminary scope of work, consisting of five key modules (peer-to-peer exchanges; data analysis and research; conventions and conferences; collection and dissemination of regional and global best practices; and “Habitat Labs” for creating diverse teams of experts to respond to specific challenges and opportunities);
- Endorsement of the Hub approach by partners in Argentina, Colombia, the United Nations Economic Commission for Latin America and the Caribbean (ECLAC) and UN-Habitat.

The discussion segment included expressions of support from colleagues in other regions and from organizations representing networks in the region. There was consensus that the “network of networks” approach would generate partnerships dedicated to achieving the goals of the New Urban Agenda.

Next steps for the Hub include choosing a technology platform; continuing to promote the Hub and widen its reach; securing more resources for expanding its activity; planning a regional housing forum in mid-2018; and following up with attendees who expressed their interest in learning more about the Hub.
