1. Adoption of the Agenda.

2. Adoption of the Draft Minutes of the 62nd Regular Meeting of the CPR, which was held on 14 September 2016.

The draft Minutes was shared with the CPR Members on 17 November 2016. Under this item, the Committee will be invited to consider and subsequently adopt the draft Minutes as contained in document HSP/CPR/63/L.1.

3. Adoption of the Work Schedule for the CPR for 2017.

The Chair will present the CPR work schedule for 2017 for consideration and adoption.

4. Executive Director's Briefing to the CPR.
