**Item 1**

**Opening of the resumed meeting**

1. Pursuant to General Assembly resolution 73/239 of 20 December 2018, the Executive Board of UN-Habitat held its first meeting at the headquarters of UN-Habitat in Nairobi on the afternoon of Thursday, 30 May 2019, in the margins of the first session of the United Nations Habitat Assembly (UN-Habitat Assembly). During that meeting, the Executive Board decided, with respect to its workplan, to resume at a later date between 18 and 20 November. At its first meeting, on 21 June, the Bureau of the Executive Board recommended that the continuation of the first meeting should be held on 19 and 20 November. The resumed meeting will therefore be opened at 10 a.m. on Tuesday, 19 November 2019 at UN-Habitat headquarters. The membership of the Executive Board is set out in annex I to the present note and the geographical distribution of officers elected during the first meeting can be found in annex II.

**Item 2**

**Organizational matters**

**(a) Adoption of the agenda**

2. Under agenda item 2 (a), the Executive Board will adopt its agenda for the resumed first meeting and thereafter decide on the organization of work for the meeting and beyond. A proposed organization of work and timetable for the meeting is set out in annex II. The provisional agenda was approved during the first meeting of the Executive Board, held on 30 May 2019. ### **Item 3**

#### **Financial, budgetary and administrative matters**

4. Under agenda item 3, the Executive Board will discuss the financial situation, the use of resources, the resource mobilization strategy and the ongoing restructuring of UN-Habitat. The Executive Board will be invited to provide guidance on the resource mobilization strategy, with a view to providing the organization the financial and institutional capacity to achieve the objectives of its 2020–2023 strategic plan. The Executive Board will also be briefed on the ongoing restructuring process and its implementation. The Executive Director will read her statement to open the discussion on the financial status of the organization and the Board will then consider the report on financial, budgetary and administrative matters.

5. In addition, under this agenda item and in line with rule 5 (f) of the rules of procedure of the Executive Board, which gives competency to the Executive Board to oversee the compliance of UN-Habitat with evaluations and to support auditing functions, the Executive Board will be presented, for its information, the financial report and audited financial statements of UN-Habitat for the financial year ended 31 December 2018 and report of the Board of Auditors.

### **Item 4**

#### **Approval of the annual work programme of the United Nations Human Settlements Programme and of the budget of the United Nations Habitat and Human Settlements Foundation for 2020**

6. Pursuant to rule 5 (c) of its rules of procedure, the Executive Board has the mandate to approve and oversee the implementation of the annual work programme and budget and the resource mobilization strategy of UN-Habitat, in accordance with the strategic plan and political guidelines provided by the UN-Habitat Assembly. Under agenda item 4, the annual work programme of the United Nations Human Settlements Programme and the budget of the United Nations Habitat and Human Settlements Foundation for the year 2020 will be presented to the Executive Board for its consideration and approval.

7. The Executive Board will also consider the report of the Advisory Committee on Administrative and Budgetary Questions on the proposed work programme of the United Nations Human Settlements Programme and on the budget of the United Nations Habitat and Human Settlements Foundation for 2020.

## Item 5

### Report on the implementation of the UN-Habitat strategic plan

#### (a) Implementation of the 2014–2019 UN-Habitat strategic plan

##### i. Date of receipt of the 2019 annual report on the 2014–2019 UN-Habitat strategic plan

8. As decided in the workplan approved by the Executive Board during its first meeting, the annual report on the implementation of the strategic plan will be included on the agenda of its meetings each year. The strategic plan for the period 2014–2019 will end on 31 December 2019. Accordingly, under agenda item 5 (a) (i), the Executive Board will be invited to recommend the date by which the Board would receive the 2019 annual report on the 2014–2019 strategic plan. It should be noted that at its meeting on 21 June 2019, the Bureau of the Executive Board recommended that the annual report should be received by the Executive Board during its annual meeting in late March or early April 2020.

##### ii. Date of receipt of the final report for the full cycle of the 2014–2019 UN-Habitat strategic plan

9. Under item 5 (a) (ii), the Executive Board will be invited to recommend the date by which the Board would receive the final report on the strategic plan for the entire 2014–2019 cycle, recalling that at its meeting on 21 June 2019, the Bureau recommended that the final report should be received by the Executive Board during its annual meeting in late March or early April 2021.

##### iii. Date of receipt of the evaluation report on the full cycle of the 2014–2019 UN-Habitat strategic plan

10. The Bureau recommended that the final report on the strategic plan for the period 2014–2019, to be received by the Executive Board in late March or early April 2021, should also include a final evaluation report on the 2014–2019 strategic plan that is based on an evaluation to be conducted in 2020. The Bureau also recommended that an update on the final report and on the evaluation inception report should be considered by the Executive Board during its annual meeting to be held in late March or early April 2020.

#### (b) Briefing on the preparations for the implementation of the 2020–2023 UN-Habitat strategic plan

11. The first session of the UN-Habitat Assembly adopted resolution 1/1 on the UN-Habitat strategic plan for the period 2020–2023, approving the strategic plan and aligning its cycle with the four-year cycle of the UN-Habitat Assembly. Pursuant to paragraph 3 of resolution 1/1, the Executive Board will be briefed on the preparations of the 2020–2023 UN-Habitat strategic plan, in particular on the results framework, the impact communication strategy, the partnerships strategy and the typology of human settlement demands. Under this item, the Board will also be invited to approve the results framework that was circulated among Member States for comments and feedback on 8 August 2019.

## Item 6

### Briefing on the status of implementation of resolutions and decisions adopted during the first session of the UN-Habitat Assembly

12. Under agenda item 6, the Executive Board will be briefed by the Executive Director on the status of implementation of resolutions and decisions adopted by the first session of the UN-Habitat Assembly, namely resolution 1/2 on United Nations system-wide guidelines on safer cities and human settlements; resolution 1/3 on enhancing capacity-building for the implementation of the New Urban Agenda and the urban dimension of the 2030 Agenda for Sustainable Development; resolution 1/4 on achieving gender equality through the work of the United Nations Human Settlements Programme to support inclusive, safe, resilient and sustainable cities and human settlements; resolution 1/5 on enhancing urban-rural linkages for sustainable urbanization and human settlements; and decision 1/3 on arrangements for the transition towards the new governance structure of the United Nations Human Settlements Programme.

13. The Executive Board will also be invited to consider the establishment of an ad hoc working group to continue discussions on the development of a UN-Habitat stakeholder engagement policy, in accordance with the mandate provided to the Executive Board by the UN-Habitat Assembly in its

decision 1/3 on arrangements for the transition towards the new governance structure of the United Nations Human Settlements Programme and in line with rule 11 of the rules of procedure of the Executive Board, which provides that the Executive Board may establish ad hoc working groups as and when it deems necessary.
