# Item 1

# **Opening of the session**

1. Pursuant to General Assembly resolution 73/239 of 20 December 2018, the Executive Board of UN-Habitat held its first meeting at the headquarters of the United Nations Human Settlements Programme (UN-Habitat) on the afternoon of Thursday, 30 May 2019. Subsequently, it resumed its first meeting at the headquarters of UN-Habitat on 19 and 20 November 2019. At that meeting, in paragraph 3 of its decision 2019/4, the Executive Board decided to hold its first session of 2020 from Tuesday, 31 March to Thursday, 2 April 2020. The membership of the Executive Board beginning on 31 May 2019 is set out in annex I to the present document, while the geographical distribution of officers elected at the first meeting, in 2019, and to be elected at the first session of 2020, is set out in annex II.

The Executive Director will provide a briefing to the Executive Board in preparation for the discussion on the financial, budgetary and administrative situation of UN-Habitat.

# Item 4

6. Pursuant to rule 5 (c) of its rules of procedure, the Executive Board has the mandate to approve and oversee the implementation of the annual programme of work and budget and the resource mobilization strategy, in accordance with the strategic plans and political guidelines provided by the UN-Habitat Assembly. Accordingly, under this item, the secretariat will update the Executive Board on the status of the draft annual work programme of UN-Habitat and the draft budget of the United Nations Habitat and Human Settlements Foundation for 2021.

7. As requested by paragraphs 13 and 14 of decision 2019/1, the Executive Director will also present additional information responding to questions and issues raised during the resumed first meeting of the Executive Board in 2019 on the work programme of UN-Habitat and the budget of the United Nations Habitat and Human Settlements Foundation for 2020. The Executive Director will also brief the Board on the follow-up to the recommendations of the Advisory Committee on Administrative and Budgetary Questions on the work programme and budget for 2020.

10. Under this sub-item the secretariat will update the Executive Board on the progress made in the implementation of the strategic plan for the period 2020–2023, in accordance with paragraphs 4, 5, 7, 8, 9, 10 and 11 of decision 2019/1 and paragraph 7 of decision 2019/4. In particular, the Board will be invited to review and approve the following: the draft results framework, the draft communication strategy, the draft partnerships strategy, the draft resource mobilization strategy and the draft results-based management strategy. The secretariat will also update the Board on the preparation of the draft accountability framework and invite the Board to consider the draft concept note on the proposed format and content of a financial plan. The secretariat will also provide an update on the review of the impact of UN-Habitat engagement with the private sector and with non-governmental partners and on the review of the investment funds.

Action: Consideration and possible approval of the results-based management strategy, the results framework, the partnerships strategy, the communication strategy, the resource mobilization strategy and update by the Executive Director on the preparations of the draft accountability framework and on the draft concept note on the proposed content and format of the financial plan, followed by discussion.

12. In addition, and in line with paragraph 2 of decision 2019/3, the secretariat will present, for consideration by the Board, a draft concept note, including financial costing, on the implementation of a review process for the United Nations System-Wide Guidelines on Safer Cities and Human Settlements, in accordance with resolution 1/2. The secretariat will also provide an update to the Board on the draft capacity-building strategy, in accordance with paragraph 3 of decision 2019/3. The secretariat will present, for consideration by the Board, a report on the status of development of tools, thematic guides and a compendium on enhancing awareness, best practices, and mainstreaming of rural-urban linkages pursuant to decision 2019/4.
