• Which form of governance is conducive for the development of SUP and can facilitate their implementation?

• Do sub-national urban policies reinforce existing government architectures or can they open new multilevel scenarios hitherto unknown? Are they one more level in the assimilable cascade scheme of territorial planning? Or could they have a life of their own?

• How can SUP contribute to better coordination between the three levels of government (national, regional and local) and at the same time to reduce the limitations that cities face to carry on effective projects and solutions for real change?

• What are the indicators and metrics to consider in monitoring and evaluating SUP? Should they be the same as those of national urban policies? Or is it possible to introduce some different measurements? What role can open data platforms play here by means of direct participation of people on the ground?

Access through a web browser

- 1. Go to https://cloud.globenti.com/es/webapp (preferably using Google Chrome or Mozilla Firefox).
- 2. Enter the event code: #EGM2020
- 3. Select the interpretation language you wish to listen to.
- 4. Minimize this window or open a different tab to follow the videoconference meeting in the foreground.

Access through a mobile app

- 1. Download the "Globenti" app (Android or iOs) in a mobile device different from the one you will be using for the videoconference.
- 2. Open the app and enter the event code. Select the interpretation language you wish to listen to.

- 3. In order to avoid your microphone picking up the interpretation audio and adding noise to your videoconference call please, use your headphones when listening to the interpretation.
- 4. While listening to the interpretation, you will be able to use other apps in your mobile device or lock the screen to save battery power.

.If you want to be prepared in advance, please:

- Download the Globenti free app from Play Store or App Store.
- Have some headphones ready to use with to your device.
- Ensure your device has a good battery level.
