<sup>&</sup>lt;sup>1</sup> At its first session of 2020, held online on 29 June 2020, the Executive Board decided, in its decision 2020/2, that its second session of 2020 would be held for a duration of three days, from 27 to 29 October 2020, and adopted a provisional agenda for the second session. At its meeting of 10 August 2020, the newly elected Bureau of the Executive Board further reviewed, amended and confirmed the provisional agenda as reflected in decision 2020/2. In the light of the evolving global situation with regard to the coronavirus disease (COVID-19) pandemic, at the same meeting the Bureau recommended that the second session of 2020 of the Executive Board be held online.
