Annotated provisional agenda

Item 1

Opening of the session

- 1. The Executive Board began its first session of 2020 online on 29 June 2020 and resumed it on 29 July 2020 to elect the Bureau for the period 2020–2021 and take up any issues arising under any other matters. At its first session of 2020, the Executive Board, in its decision 2020/2, decided that its second session would span three days, from 27 to 29 October 2020, and also decided on the provisional agenda for the session. At its meeting of 10 August 2020, the newly elected Bureau of the Executive Board amended the provisional agenda as reflected in document HSP/EB.2020/19, taking into account an important item for discussion and possible approval at its second session of 2020, namely the work programme and budget for 2021. Because of the coronavirus disease (COVID-19) pandemic, the first session of 2020, originally scheduled to be held on 31 March 2020, was postponed and a number of the items on its agenda were deferred to the second session.
- 2. Under this item the Chair will declare the second session of 2020 open and outline the protocols for the session.
- 3. The membership of the Executive Board beginning on 31 May 2019 is set out in annex I to the present document, while the geographical distribution of officers elected to the Bureau at the first session of 2020 is set out in annex II.

(a) Organizational matters

- 4. Under this sub-item, the Chair will inform participants that, at its first session of 2020, the Executive Board authorized the secretariat to use for the second session of 2020 the already prepared documents pertaining to the agenda items deferred until the second session. Those documents have been updated only to the extent absolutely necessary.
- 5. The Chair will also inform participants that, because of the limited availability four hours per day of simultaneous online interpretation in the six United Nations official languages, the Bureau at its meeting of 10 September 2020 made recommendations regarding which agenda items would be discussed with interpretation. The Chair will confirm that the Executive Board will work for approximately six hours per day, two in English only and four with interpretation, exercising flexibility where possible.
