Dear Chris,

at the meeting of the Bureau on August 10 I pointed out that the Covid 19 pandemic has changed the lives of all people on the planet. It has created havoc, curtailed travel, stopped tourism, normal education activities and caused massive death world wide. The pandemic is concentrated in cities and settlements. It is exerting an enormous burden on health care systems and has reduced economic activity instigating widespread job loss and unemployment. Almost all cities and settlements in the world are confronted with the same problem and menace which does not seem to be going away soon. In this situation in my opinion we cannot in UN-Habitat continue business as usual but must see how through coordination and a concerted multilateral approach the UN system can propose possible solutions to better deal with the problem. In that context I proposed that a special session of the Executive board should be considered as an option. I did not propose that it should be held just considered as a possible option. I strongly believe that it is not healthy that UN-Habitat continues with business as usual as it is clear that our lives and activities have changed fundamentally.
