



Support to the implementation NUA within Europe

Contribution to European urban policy debate

Support to development cooperation and humanitarian activities in other parts of the world

Through project "URBAN2030", UN-Habitat supports the deployment of SDGs indicators at the local level.

Through URBAN MAESTRO, UN-Habitat leads a pan-European effort to document and understand European practices for the informal governance of urban design. (internal to EU): UN-Habitat is an active participant to meetings of the Urban Development Group (UDG) and contributes to policy debates on the implementation of the Urban Agenda for the EU (UAEU)

(external to EU): UN-Habitat acts as an adviser to the European Union Programme on "International Urban Cooperation" (IUC). EU and its Member States are longstanding supporter of UN-Habitat activities in emerging economies, developing countries and crisis contexts.

European Commission is among top donors of UN-Habitat. Ca. \$400 million of earmarked contributions in the last decade.

## Regional UN System Meeting for Europe and Central Asia on COVID response in the Western Balkans and IBC updates

**UNECE:** shared understanding with EU on COVID-19 crisis in the Western Balkans: health situation, the socio-economic impact and government responses.

EU: shares the analysis of the UN regarding the challenging situation in the Western Balkans. The EU support to the coronavirus crisis and recovery takes the form of financial assistance.

**UN and the EU** to work hand in hand connectivity, green recovery and social issues. Dialogue between civil society and governments, awareness of intersecting forms of discrimination and gender-sensitive investments should be encouraged. Among other priorities, digitalization will be an important driver of the recovery.



#### Issue-based Coalitions for Eastern Europe and Central Asia

- Mainstreaming urban development into environment/ Climate Change and Migration IBCs; urban IBC engagement and joint programming with UN entities (in close collaboration with UN-Habitat Brussels Office).
- Active role in regional coordination of Socio-Economic Recovery Frameworks at country level.

#### **Regional Joint Programming**

- Implementation of the regional programme on Smart Sustainable Cities (UNDA T12) together with UNECE.
- Finalization of the **Evidence-based policies for sustainable housing and urban development** (UNDA T10) together with UNECE.
- **Regional urban profiling for the Western Balkans** linking with the CCA processes, building on indicators for monitoring the urban SDG targets, NUA in addition to country level data sets.
- Upcoming joint programme on Enhanced resilience to COVID-19 through greener cities: harnessing the power
  of nature for green and cost-effective policy solutions to urban air pollution (UNDA T14) together with UNEP.

#### **UN-Habitat activities**

- Contribution to joint proposal in assistance to the residing and partner agencies drawing on UN-Habitats expertise.
- Development of potential partnerships to ensure accessible and inclusive and safe public spaces in the post-recovery stage of the COVID-19 pandemic.

# UN-Habitat's recent initiatives in the Western Balkans and their COVID-19 dimension



#### **Activities and strategic potential**

- The EU support to the Western Balkans in tackling the crisis and post-pandemic recovery takes the form of financial assistance and alignment of the subregion with the EU response to COVID-19.
- The main goal to support the economic recovery and provide a lifeline for businesses, including through 1.7 billion EUR in grants and loans by the European Investment Bank (EIB).

#### **UN-Habitat activities**

- UN-Habitat extended technical advisory services to RCO/ UNCTs in the preparation of Socio-economic Impact Assessment and Recovery Programmes in Serbia, Bosnia and Herzegovina, Montenegro and Albania.
- UN-Habitat's Office at Pristina has conducted a feasibility study for a sustainable Social Housing Programme in Kosovo funded by the Council of Europe Development Bank CEB which will include considerations raised by \*AAny reference to Kosovo in United Nations the COVID-19 crisis.

Bosnia and Herzegovina	The alignment of activities with the UNSDCF priorities to support UNCT implementation.
Montenegro	Support of RCO/ UNCT in mainstreaming urbanization to the CCA/ UNSDCF implementation.
North Macedonia	Support of RCO/ UNCT in mainstreaming urbanization to the CCA/ UNSDCF implementation.
Serbia	Support of the RCO/ UNCT in the CCA/UNSDCF process.
Georgia	Support of RCO/ UNCT in mainstreaming urbanization to the CCA/ UNSDCF implementation.

- Capital Investment Programmes, supported by Sweden and the local municipalities.
- Feasibility study for a sustainable Social Housing Programme in Kosovo.

**MONTENEGRO:** UNDA T12 regional programme on Smart Sustainable Cities.

NORTH MACEDONIA: Potential joint programming.


**SERBIA:** Potential joint programming.



## **Engagement with CCA and UNSDCF in the CIS**

Armenia	Support of the RCO/ UNCT in mainstreaming urbanization to the CCA/ UNSDCF implementation including green economic growth pillar.
Azerbaijan	Engagement with the RCO/ UNCT in the CCA/UNSDCF process.
Belarus	Active partnership in CCA/ UNSDFC process, contribution on: green cities; capacity building; climate change mitigation and; NUP; urban monitoring of the SDGS and NUA targets.
Russian Federation	Engagement/coordination with in the UN team in the country



#### CIS: Country and territory level engagement

ARMENIA: Potential joint programming on National Urban Policy, housing, inclusive cities.

**AZERBAIJAN:** Engagement with UNEP and IOM in developing an Adaptation Fund proposal for Caspian Sea Region, inclusive cities.


**BELARUS:** UNDA T12 regional programme on Smart Sustainable Cities.

UN-Habitat finalized the first SDG Voluntary Local Review (VLR) for Moscow in December 2020



- More than 130 local stakeholders involved
- close work with local authorities and federal entities
- methodology adjusted and adapted to the national context
- Preparation of the **Best**Practices compendium
