Main areas for SP in LAC

- **Housing/Informal Settlements:** related to the new social contract for LAC. Allows for development of the area/based and neighborhood integrated approach.
- **SDG Cities / Localizing SDGs:** Increasing demand from RCs and UNCTs. Positions UN-Habitat in integration of Whole of UN delivery at city/neighborhood level. Calls for increased capacities and skills as "curators" of SDGs at city level.
- **Community integration:** New UN approaches for integration of migrants in cities and neighborhoods.

- **Regional Integration:** Catalytic role in promoting integration of regional networks, stakeholders, institutions, alliances around key areas of the socioeconomic recovery at local level.
- *Knowledge transfer:* Empowerment of regional, national and local actors in a way that facilitates contextualized solutions integrating international and local knowledge.
