5. REVIEW OF THE PROPOSED ORGANIZATION OF WORK AND WORKPLAN FOR THE CREE





- 1. The CPR Bureau may wish to propose to the President of UN-Habitat Assembly a joint Bureau meeting in June 2022, as provided for in the rule 28 of the rules of procedure of the UN-Habitat Assembly
- 2. The Bureau may hold active meetings from September 2022. Between September to December 2022 the Bureau may meet primarily to:
 - a. to consult and conclude on the provisional agenda and exact dates for the second CPR open ended meeting currently scheduled to be held from 29 May to 2 June 2023.
 - b. to consult and advise the Bureau of the UN-Habitat Assembly on the provisional agenda and dates for the second session of the UN-Habitat Assembly currently scheduled to be held from 5 to 9 June 2023.
- 3. The Bureau may hold monthly meetings between January and June 2023 to prepare and monitor progress on the preparations for the CPR open ended meeting to prepare for the UN-Habitat Assembly and to support preparations for the second session of the UN-Habitat Assembly itself.
