Annotated provisional agenda

Item 1

Opening of the session

- 1. The Executive Board of the United Nations Human Settlements Programme (UN-Habitat) held its first session of 2021 online on 7 and 8 April 2021. The report of the Executive Board on its work at that session is set out in document HSP/EB.2021/10, while the decisions adopted by the Board at that session are set out in document HSP/EB.2021/11.
- 2. At its first session of 2021, in its decision 2021/4, the Executive Board agreed that the second session of 2021 of the Executive Board would be held for a duration of two or three days between 16 and 18 November 2021, with the understanding that the Bureau would subsequently recommend the number of days and any change required to the provisional agenda. The Bureau of the Executive Board, at its meeting held online on 8 September 2021, recommended that the second session of 2021 of the Executive Board be held for a duration of two days. The Bureau further recommended that the session should be held on Monday, 15 November and Tuesday, 16 November 2021. The recommendation of the Bureau took into consideration the provisional agenda for the session; the fact that the Executive Director of UN-Habitat was required to attend in person; the second regular session of the United Nations System Chief Executives Board for Coordination, to be held in New York on 18 and 19 November 2021; and the availability of dates on the meetings calendar of the Division of Conference Services of the United Nations Office at Nairobi for the year 2021.
- 3. The provisional agenda, as agreed upon by the Executive Board in its decision 2021/4, and further reviewed and amended by the Bureau at its meeting on 8 September 2021, is set out in document HSP/EB.2021/12.
- 4. Under this item, the Chair will declare the second session of 2021 of the Executive Board open and outline the protocols for the session.
- 5. The membership of the Executive Board beginning on 31 May 2019 can be found here, while the geographical distribution of Bureau for the period the 2021–2022 is as follows:

Organizational matters

(a) Adoption of the agenda and the workplan for the second session of 2021

- 6. - 7. The provisional agenda, which is contained in document HSP/EB.2021/12, was decided upon by the Executive Board in paragraph 4 of its decision 2021/4, adopted at its first session of 2021, and was reviewed and amended by the Bureau at its meeting on 8 September 2021 to include an item on the review of the effectiveness of the oversight functions of the Executive Board with regard to its working methods, ensuring congruence with the other governing bodies of UN-Habitat.

Action: Briefing on organizational matters, including those related to interpretation services, and adoption of the provisional agenda and the workplan for the second session of 2021.

Item 3

Reports by the chairs of the ad hoc working groups

- 9. In line with the decisions of the Executive Board, in particular paragraph 7 of decision 2019/2 creating the ad hoc working group on programmatic, budgetary and administrative matters and paragraph 5 of decision 2019/3 creating the ad hoc working group on the development of a draft stakeholder engagement policy, the chairs of the two ad hoc working groups will report on the work of the groups. The report by the Chair of the ad hoc working group on programmatic, budgetary and administrative matters will include an update on the alignment of the planning cycles of UN-Habitat with the quadrennial comprehensive policy review (QCPR) process, as referred to in paragraph 16 of decision 2020/3 and paragraph 40 of the report of the Executive Board at its first session of 2021 (HSP/EB.2021/10), in which it was agreed that "there was a need to continue consultations on the various options for the alignment of the quadrennial comprehensive policy review process with the UN-Habitat planning cycles" and recommended that "the ad hoc working group on programmatic, budgetary and administrative matters of the Executive Board continue its discussions and report thereon to the Executive Board at its second session of 2021".
- 10. In line with paragraph 40 of the report of the Executive Board at its first session of 2021 (HSP/EB.2021/10), the Executive Director will also brief the Executive Board, if requested, on the views of the President of the United Nations Habitat Assembly of the United Nations Human Settlements Programme with regard to the alignment of the strategic planning cycles of UN-Habitat with the QCPR process.

Action: Briefings by the chairs of the ad hoc working groups and a briefing by the Executive Director, focusing specifically on the alignment of the planning cycles of UN-Habitat with the QCPR process, followed by discussions and recommendations by the Executive Board on the basis of the briefings.

Item 4

Financial, budgetary and administrative matters, including the implementation of the resource mobilization strategy in accordance with the strategic plan

- 11. Under this item, and in accordance with paragraph 4 of decision 2019/2, the secretariat will introduce the report of the Executive Director on the financial status of UN-Habitat. The secretariat will also provide an update on the internal restructuring and financing of UN-Habitat, the implementation of the resource mobilization strategy in accordance with the strategic plan for the period 2020–2023, and the status of staffing in the organization, grounded on equitable geographical distribution and gender parity.
- 12. In line with paragraph 3 of decision 2021/2, in which the Executive Board requested the Executive Director to submit future reports on the implementation of the resource mobilization strategy, including factual and analytical information pertaining to the achievement of the objectives of the resource mobilization strategy, to the Executive Board, the secretariat will also provide an update on the implementation of the resource mobilization strategy in accordance with the strategic plan.
- 13. The Executive Director will provide a briefing to the Executive Board in preparation for the discussion on the financial, budgetary and administrative situation of UN-Habitat.

Action: Briefing by the Executive Director on financial, budgetary and administrative matters and discussion. The Executive Board may wish to take note of the briefing and of the relevant documentation and formulate further recommendations for follow-up action.

- 14. Pursuant to rule 5 (c) of its rules of procedure, the Executive Board has the mandate to approve and oversee the implementation of the annual programme of work and budget and the resource mobilization strategy, in accordance with the strategic plans and political guidelines provided by the United Nations Habitat Assembly. Accordingly, under this item, the secretariat will present to the Executive Board the draft annual work programme of UN-Habitat and the draft budget of the United Nations Habitat and Human Settlements Foundation for 2022 for further consideration and possible approval by the Executive Board, based on feedback from the Committee for Programme and Coordination and the Advisory Committee on Administrative and Budgetary Questions.
- 15. In line with paragraph 4 of decision 2021/1, the secretariat will also brief the Executive Board on notional budget allocations for the year 2022 on the basis of projected revenue levels for 2021 for the Foundation non-earmarked budget.

Action: Briefing by the Executive Director on the draft annual work programme and budget for the year 2022. The Executive Board may wish to consider and possibly approve the draft annual work programme and budget of UN-Habitat for 2022.

Item 6

Implementation of the strategic plan for the period 2020–2023

(a) Annual report for 2020 on the strategic plan for the period 2020–2023

15. The first year of the implementation of the strategic plan for the period 2020–2023 ended on 31 December 2020. Accordingly, and pursuant to paragraph 4 of decision 2021/4, under this sub-item the Executive Board will be invited to consider the UN-Habitat Annual Report 2020, covering the first year of the implementation of the strategic plan for the period 2020–2023, but solely with reference to the year 2020.

In addition, and in line with paragraph 4 of recommendation 2021/2, adopted by the Committee of Permanent Representatives at the first meeting of the high-level midterm review, in which the Committee acknowledged that the adequate extrabudgetary earmarked funding to the Programme and the shortfall in extrabudgetary non-earmarked funding had severely restricted the ability of the Programme to achieve balanced progress in the implementation of the strategic plan for the period 2020–2023 and to monitor its implementation, and requested the Executive Director to present to the Executive Board at its second session of 2021 a focused draft work programme for 2022, the Executive Board will be briefed on the recalibration of the strategic plan for the period 2020–2023.

16. In line with paragraph 8 of recommendation 2021/2, in which the Committee called upon the Executive Director to strengthen the analysis of linkages between its operational and normative activities to increase the impact of its work in support of sustainable and inclusive recovery and requested the Executive Director to present the analysis to the Executive Board for further consideration, the Executive Board will be briefed accordingly.

Action: Briefing by the Executive Director on the UN-Habitat Annual Report 2020 on the implementation of the strategic plan of the United Nations Human Settlements Programme for the period 2020–2023 and on the recalibration of the strategic plan for the period 2020–2023. The Executive Board may wish to take note of the briefing and of the relevant documentation and formulate further recommendations for follow-up action.

Action: Briefing by the Executive Director on the actual annual income and expenditures in support of the draft financial plan. The Executive Board may wish to take note of the briefing and of the relevant documentation and formulate further recommendations for follow-up action.

Item 7

Normative and operational activities of UN-Habitat, including reporting on the programmatic activities of the Programme in 2021 and the implementation of subprogrammes, flagship programmes and technical cooperation activities, and an update on the response of the Programme to the coronavirus disease (COVID-19) pandemic.

- 18. Under this item, and in accordance with paragraph 6 (b) of decision 2019/4 and paragraph 4 of decision 2021/4, the Executive Director will provide a briefing on the implementation of the normative and operational activities of UN-Habitat, which will include a briefing on activities at the country level, and on the programmatic activities of the Programme, with a focus on engagement in housing policy issues and priorities in Europe; engagement on migration and displacement, including progress on flagship programme 4 (Inclusive cities: enhancing the positive impact of urban migration) on inclusive cities for migrants, with case studies on Burkina Faso and the response to the Venezuela crisis. The briefing will also highlight the role of UN-Habitat in supporting voluntary local reviews on the Sustainable Development Goals, in line with paragraph 10 of recommendation 2021/1, adopted by the Committee of Permanent Representatives at the first meeting of the high-level midterm review. The briefing will also reflect on the ways in which the COVID-19 pandemic is influencing the work of UN-Habitat in those thematic areas.
- 19. The briefing will also set out the ways in which normative and operational activities are integrated to build prosperity and achieve a better quality of life for all, towards the implementation of the New Urban Agenda and to achieve the urban dimensions of the Sustainable Development Goals.
- 20. In addition, under this sub-item and in line with paragraph 5 of recommendation 2021/1, adopted by the Committee of Permanent Representatives at the first meeting of the Committee for a high-level midterm review, in which the Committee requested the Executive Director to develop a plan to further develop the institutional anchoring of capacity-building as a cross-cutting function and to present the plan to the Executive Board for its further consideration and possible approval, the Executive Director will present a plan for developing the institutional anchoring of capacity-building as a cross-cutting function.

- 21. By paragraph 2 of decision 2021/3, the Executive Board requested the Executive Director, taking into account the United Nations System-wide Guidelines on Safer Cities and Human Settlements, to provide to the Executive Board at its second session of 2021 the terms of reference of a peer review mechanism and an assessment of the resources required to assess progress and propose amendments, where necessary, to the guidelines in order to ensure their effective implementation. Accordingly, the Executive Director will provide a briefing on the effective implementation of the United Nations System-wide Guidelines on Safer Cities and Human Settlements, including the terms of reference of a peer review mechanism for an effective implementation of the Guidelines.
- 22. In line with paragraph 9 of decision 2021/1, in which the Executive Board recommended the continued implementation by the Programme of the Secretary-General's reform agenda to the fullest, including strengthened cooperation with other United Nations entities, the Executive Director will provide a briefing on cooperation with the United Nations Environment Programme.

Action: Briefing by the Executive Director on normative and operational activities of UN-Habitat, including an analysis of linkages between UN-Habitat's operational and normative activities and cooperation with the United Nations Environment Programme. The Executive Board may wish to take note of the briefing by the Executive Director and of the relevant documentation and formulate further recommendations for follow-up action.

Action: Briefing by the Executive Director on the terms of reference of a peer review mechanism for effective implementation of the United Nations System-wide Guidelines on Safer Cities and Human Settlements. The Executive Board may wish to take note of the briefing by the Executive Director and of the relevant documentation and formulate further recommendations for follow-up action.
