The consultative meeting is being held in preparation for the upcoming session of the Executive Board which is scheduled to be held from 29 to 31 March 2022.

The objective of the meeting is for the Executive Director of UN-Habitat to hear from the Regional Group including guidance on the following:

		How could the funding situation of UN-Habitat be improved?
3.	<b>The high-level meeting of the General Assembly on the implementation of the New Urban Agenda to be held on 28 April 2022</b>	What topics/thematic discussions would be of interest to the Regional Group at the upcoming high-level meeting of the General Assembly on the implementation of the New Urban Agenda?
		How can the national reporting on the New Urban Agenda be improved? What support do Member States need?
4.	<b>The eleventh session of the World Urban Forum to be held from 26 to 30 June 2022</b>	What topics/thematic discussions would be of interest to the Regional Group at the upcoming eleventh session of the World Urban Forum?

Accordingly, the provisional Agenda for the meeting is as follows:

2. Expectations from the Regional Group with respect to sustainable urbanization and UN-Habitat's role;

5. The eleventh session of the World Urban Forum to be held from 26 to 30 June 2022;
6. Any other matters, including closing remarks.
