It has been six years since the global endorsement of the New Urban Agenda – a blueprint for achieving sustainable cities. During this time the world has continued to rapidly urbanize. The High Level Meeting on the implementation New Urban Agenda on 28 April, provides the opportunity to take stock of progress and highlight areas that need particular focus. A full-day series of side events on the 27 April provides the opportunity to review progress through a series of lenses that relate to local implementation. The day begins by discussing how cities - particularly those in developing economies- can access the finance they need to deliver on SDGs and the New Urban Agenda. Following this, a high-level panel will focus on the need to accelerate the implementation of the New Urban Agenda and SDGs in the 8 years left until 2030. The day will continue with three events that allow a deeper focus on particularly stakeholders - women, migrants and youth - that have a key role to play to ensure cities are safe, inclusive, resilient, sustainable and peaceful. The day's events reaffirm the need for all-of-society action towards a more sustainable, inclusive urban future.

# **Event: Transformative Urban Finance for the SDGs**

# Abstract

Developing countries are going through urban transition, green transition and productive transition which calls for transformation in the way international development finance is deployed. The twin disruptions of climate crisis and urbanization require us to refocus attention on subnational finance as stressed in paragraph 34 of the Addis Ababa Action Agenda in line with the New Urban Agenda. However, the unmet financing needs of cities to address the challenges of inequality and environmental sustainability and meet the SDGs is in its trillions. Meeting this financing gap requires leveraging a broad range of financial resources towards sustainable outcomes including the response to COVID-19 recovery. UNCDF as the UN's hub for subnational finance and UN-Habitat as the UN agency for cites, have joined forces through the SDG Cities Global Initiative to help cities reach their unmet financing needs for sustainable development by deploying a number of financing instruments including loans, guarantees, grants, technical assistance, municipal bonds, etc. This event will bring together local governments, international financing institutions and other relevant stakeholders to demonstrate various financing vehicles and results from this UNCDF/UN-Habitat fused offering, and to project how such initiatives can move to scale in this Decade of Action. Cities will be invited to participate and have access to advice, resources and technical assistance to strengthen local revenue, improve public financial management, improve creditworthiness and access debt finance and blended capital for SDG impact projects.

# Description

The world is urbanizing rapidly, yet the global financial ecosystem is not working for cities and local governments. Currently people living in urban areas make up 55% of the global population. This will increase to 67% by 2050, as the world's urban population increases by 2.3 billion. Accompanying this urban transition are the green transition and the productive transition, with the former addressing the climate crisis that we live in and the latter on low productive capacity in many developing countries.

Cities and local governments are at the forefront of service delivery, sustainable development and emergency responses (as shown during the COVID-19 pandemic). However, the unmet financing needs of cities to address the challenges of inequality and environmental sustainability and meet the SDGs is in its trillions. The twin disruptions of climate crisis and urbanization require us to refocus attention on subnational finance as stressed in paragraph 34 of the Addis Ababa Action Agenda, which commits to building strong subnational government capacity and leveraging the catalytic impact of subnational finance for local transformation. This is in line with one of the critical elements to the achievement of sustainable development in cities in the New Urban Agenda -- effective public financial management and financing.





Without effective policy environment and financing mechanisms, the potential for urbanization to drive sustainable development will be lost. Even worse, the resulting unsustainable built environments will exacerbate global problems. Meeting this financing gap requires leveraging a broad range of financial resources towards sustainable outcomes.

To this end, UNCDF – the UN's hub for subnational finance and UN-Habitat – the UN agency for cites, have joined forces through the SDG Cities Global Initiative to help cities reach their unmet financing needs for sustainable development. This Fused Offering provides services to cities in two main categories. The first involves supporting cities to strengthen an enabling environment for financing sustainable development, such through the assessment and strengthening of Own Source Revenue; asset management systems; public expenditure and financial management systems; policy impact, and creditworthiness. The second provides instruments to develop and finance pipelines of urban SDG impact projects. through debt (bonds and loans) or equity financing; and blended finance (the Cities Investment Facility).

Examples of early results include US\$2 million revenue increase in the city of Hargeisa (Somaliland), US\$23 million water infrastructure bond in Tanga City (Tanzania) to support Tanga Urban Water Authority and Sanitation (UWASA) to issue a fixed rate bond for the construction of water infrastructure (this will be listed on the Dar es Salaam stock exchange); working with Kampala Capital City Authority (Uganda) for a Green Bond; partnership with FirstRand (South Africa) and the Johannesburg stock exchange to securitize environmentally friendly projects from countries of the regions with listing on the Johannesburg Stock Exchange and cross-listing on the London Stock Exchange, and a pipeline of 55 projects with combined value of US\$1.7 billion being steered towards investment partners in the City Investment Facility powered by the Dual Key approach.

The event will bring together local governments, international financing institutions and other relevant stakeholders to demonstrate various financing technical assistance tools and vehicles, as well asresults from this UNCDF/UN-Habitat fused offering. UN Member States and cities will be invited to participate and have access to advice, resources and technical assistance to strengthen local revenue, improve public financial management, improve creditworthiness and access debt finance and blended capital for SDG impact projects.

# Event: High-Level Panel: Accelerating the Implementation of the New Urban Agenda and the SDGs

#### Background

UN-Habitat is the UN agency charged with promoting socially and environmentally sustainable towns and cities. In 2016, the UN system convened Habitat III in Quito, Ecuador, the third conference in 40 years addressing the issues of sustainable urbanization and adopted the New Urban Agenda. The NUA is an action-oriented document that sets global standards of achievement in sustainable urban development, rethinking the way we build, manage, and live, in cities. It offers countries a road map to achieve the SDGs, and specifically SDG 11, by 2030, assuring that no one and no space is left behind.

On April 28<sup>th</sup>, 2022 the President of the General Assembly will convene a High Level Meeting on Sustainable Urbanization, held as a review of the NUA, six years after it was adopted. The goal of the meeting is to further highlight the need for sustainable cities, the work cities and member states are undertaking, and strategies that can accelerate action towards the achievement of the 2030 Agenda.

#### **Description of the Event**

The High-Level Panel on Accelerating the Implementation of the New Urban Agenda and the SDGs aims to create a space for dialogue and exchange between local and national governments and civil society. Six years after Habitat III took place in Quito, Ecuador, this panel aims to reflect on the advances that countries around the world and their governments have made towards the implementation of the SDGs and NUA, including highlighting the different projects that Ecuador itself has undertaken as an example of sustainable urban development.

Hosted by the Ecuadorian Minister of Urban Development and Housing, Darío Herrera, this High-Level panel, will recount the path forward from Habitat III, highlighting what countries and cities have accomplished since 2016 to assure the acceleration of the SDGs and the local implementation of the New Urban Agenda, as well as what their goals and ambitions are as we look forward to 2030. This panel seeks to celebrate the accomplishments and unique solutions that cities and countries have implemented as well as to share ideas and methodologies to continue creating positive change and capacity building around the world.

As it is emphasized by the 2030 Agenda and the New Urban Agenda, adequate and equitable sustainable development cannot be achieved without creating holistic synergies between government, civil society, academia, and the public sector. Each sector must work conjointly towards the achievement of the SDGs and the NUA, their actions being reflective of the needs of local citizens and the individual spatial realities. Thus, this panel will include members of civil society organizations working to create safer and more inclusive urban environments through the implementation of the SDGs. The panelists from civil society organizations will present the most pressing issues facing their communities, what





their organizations do to confront these problems, and the essential steps they see towards finding lasting solutions. The panel will not only celebrate what these organizations are doing locally but create a space for dialogue between civil society and government to learn from each other in order to create a more lasting impact.

The format is a hybrid "Davos-style" with each speaker making a 5-minute introduction followed by a discussion in the panel and with the audience. The idea is to foster an open debate and lively interaction.

#### **Objectives**

- i. To promote women's equal rights in leadership at all levels of decision-making, including subnational and local governments.
- ii. To recognize the importance of women leadership of cities and businesses to drive more equal and prosperous urban society
- iii. To galvanize support for women-led cities by women-led business through the SDG Cities Global Initiative
- iv. To enable women's economic empowerment and access to equal opportunities and finance

#### Summary – abstract

Women and girls represent half of the world's population and also half of its potential. Women's equal participation, decision-making and leadership in political and public life is essential to achieving the Sustainable Development Goals (SDG) by 2030. Encouraging women to take on leadership roles has the potential to enable financial independence, economic empowerment, confidence, self-esteem, and to become role models for upcoming young women. Women in leadership enables the perspectives and lived experience of women and girls to be better reflected in decision making and is therefore key to ensuring an equal, inclusive and fair future society.

However, women are significantly underrepresented at all levels of leadership and decision-making worldwide and achieving gender-parity is far off. Currently only 22.5% of the 193 UN Member States are led by women, around 5% of mayors worldwide are women, and 8.1% of the CEOs of the top 500 companies are women. The global Sustainable Development Goals (SDG) pledge to end poverty, protect the planet, end gender discrimination and ensure that all people enjoy peace and prosperity by 2030. As long as women continue to be excluded in leadership roles, and while they continue to face multiple obstacles as they progress into such roles, major gaps in achieving the SDGs will prevail.

Cities, which accommodate 55% of world's population and are key to the local, "end-mile" achievement of the SDGs. Providing women with the right platform to share their ideas can enrich an organization's overall outlook and strategy and achieve tangible benefits. Mayors and especially women mayors, with the support of city networks, can provide a platform where other women and girls can express their ideas, demonstrate positive ideas and contribute to the local, national and global discourse that







shapes cities. As we seek to encourage and promote women leadership of cities, it is key that their positive impact is acknowledged, demonstrated and highlighted.

SDG Cities is a global initiative that aims to support 1000 cities accelerate their achievement of SDGs and positively impact on 1 billion lives by offering a systematic way to support cities becoming sustainable and resilient. It does this by connecting data to inclusive, evidence-based strategic planning, to high impact project development and financing. It accompanies this process by strengthening local institutional capacity and systems in key areas of data management, governance, planning, financing, and service delivery - foundations for urban transformation. It is implemented at scale through the provision of digitized tools, technical support hubs and a Cities Investment Facility that channels finance into SDG impact initiatives.

SDG Cities aims to empower and promote women-led and women-centred cities by launching a "Women-led businesses for Women-led cities" window. This brings women CEOs, feminist CEOs and women mayors together to support the success of women-led and women-centred cities. It will provide a platform for women in leadership positions in cities and in business to share experiences and lessons learned, identify opportunities and overcome challenges together. Most importantly, it will mobilize a catalytic fund to support local initiatives that accelerate the achievement of SDGs in Women-led cities and facilitate access to finance for women entrepreneurs.

This session will bring together women business leaders, mayors and UN principals in a dialogue on the opportunity for women leaders of businesses and cities to make a difference in accelerating the achievement of SDGs and NUA, overcoming obstacles faced by women leaders, and empowering the future generation of women leaders.

#### **Guiding Questions for discussions**

- i. What actions are needed to increase opportunities and encourage women to take up leadership positions in business and politics?
- ii. What are some of the proven advantages of having women in political or business leadership? How have their actions led to implementations of the SDGs and NUA?
- iii. How can women mayors support women's entrepreneurship and provide opportunities for economic empowerment of women of all ages and abilities?
- iv. How can women-led businesses globally support women-led and women- centered cities and improve inclusivity of all?

Initiate the mobilisation of the SDG Cities implementation window: Women-led business for women-led/centred inclusive cities.

#### **Background information**

The 2030 Agenda and the New Urban Agenda identifies as one of their pillars, the purpose of overcome all forms of segregation, marginalization and exclusion of territories and people. Leaving no one or any territory behind has been the urge for every city, to promote the social, economic, cultural, spatial, and political inclusion of their inhabitants, without distinction. This situation is exacerbated when cities face the challenges of human mobility, where forging inclusive territories, advancing in the guiding principles of the right to the city, and recognize diversity as a source of prosperity, is essential for having inclusive, prosperous, and sustainable cities.

Over the last few years, the cities and countries of Latin America and the Caribbean have faced a phenomenon of mixed migratory flows resulting from refugees and migrants fleeing Venezuela. According to data from national migration authorities and other sources an estimated 6.04 million refugees and migrants have moved around the world, of which around 4.9 million are in Latin America and the Caribbean. These refugee and migrant populations reside primarily in Colombia, Peru, and Ecuador and impact cities in significant ways, presenting important challenges for local governments and host communities.

In this context, the European Union has decided to support the strategic alliance between UNHCR, IOM, and UN-Habitat for the project "Inclusive Cities, Communities of Solidarity" (ICCS) that is underway in nine pilot cities and six countries in Latin America and the Caribbean. The ICCS project promotes an innovative urban-territorial approach that addresses existing vulnerabilities while levering social and territorial assets in the provision of effective responses to refugees' and migrants' integration. This creates the conditions for local governments to forge more prosperous and inclusive cities under the universal principle of the "right to the city".

To promote strategic actions from local governments, the Inclusive Cities, Communities of solidarity project has created several innovative tools such as urban profiling, data analysis and monitoring instruments, participatory urban planning tools, territorial and socioeconomic strategies, new generation of social integration centers<sup>1</sup>, and the consolidation of regional and global community of practice. #### **Objective of the event**

To position the New Urban Agenda (NUA) principles in policy directions and programmatic initiatives at the global level to highlight its impact in the effective inclusion of refugees and migrants in cities in the long-and-medium-term, as well as to transform migration into a territorial asset in host urban areas.

#### Key objectives of this particular event would be:

- Present the UN-Habitat's, IOM's and UNHCR's approach as an innovative one to tackle the challenges of effective medium-and-long-term integration of vulnerable communities in the cities in line with the principles of the NUA.
- To exchange experiences and solutions from the local government's perspective and gather/ mobilize support to the implementation of strategies and plans at the city level.
- Acknowledge opportunities of scaling up or replicating the successful experiences and good practices stemming from the different cities' representatives present.
- Establish a dialogue between different cities and civil society organizations to broaden the scope of the work done by all agencies in other cities and countries where the strategy is not implemented yet.

#### Expected outcomes

- Community of practice and local governments network of inclusive cities implementing innovative territorial approaches to refugees' and migrant' integration is expanded and consolidated.
- 50 more willing cities are added to receive support from the Inclusive Cities, Communities of Solidarity initiative and tools.

#### **Description of event**

UN-Habitat, IOM and UNHCR propose to establish a dialogue with mayors and civil society from different cities in Latin America on the role cities can play in the inclusion of refugees and migrants. The 2030 Agenda and the NUA identify both the need to overcome all forms of segregation, marginalization and exclusion of territories and people. Forging inclusive territories, advancing in the guiding principles of the right to the city, and recognizing diversity and territorial assets as a source of prosperity is essential to achieve prosperous and sustainable cities for all.

Interested mayors are invited to a dialogue and make the case on the need to mobilize international support to implement the territorial approach with all tested tools and methodologies developed by the alliance among UNHCR, IOM, UN-Habitat, and the European Union.

The event will be organized as a roundtable (fishbowl), counting on the active participation of all stakeholders mentioned, and allowing for the audience to interact. It is expected to run for 90 minutes and will be live streamed and facilitated in both English and Spanish, with interpretation available.

#### Background

UN-Habitat is the UN agency charged with promoting socially and environmentally sustainable towns and cities. In 2016, the UN system convened Habitat III in Quito, Ecuador to address the issues of sustainable urbanization and adopt the New Urban Agenda. The NUA is an action-oriented document that sets global standards of achievement in sustainable urban development, rethinking the way we build, manage, and live, in cities. It offers countries a road map to achieve the SDGs, and specifically SDG 11, by 2030, assuring that no one and no space is left behind.

On April 28<sup>th</sup>, 2022 the President of the General Assembly will convene a High-Level Meeting on Sustainable Urbanization, as a review of the NUA, six years after it was adopted. The goal of the meeting is to further highlight the need for sustainable cities, the work cities and member states are undertaking, and strategies that can accelerate action towards the achievement of the 2030 Agenda.

One of the key tenants of the both the SDGs and the NUA is assuring that no one is left behind. The UN and many cities place a special focus on those most marginalized; children and youth, people of all genders, indigenous peoples and those with mental and physical disabilities, to name a few.

Fondation Botnar, in partnership with UN-Habitat, will host side events to the High-Level meeting at the UN General Assembly in New York. Building on Phase one of its very successful Youth 2030 Cities initiative, youth, civil society, and governmental representatives will discuss the role of youth in achieving the SDGs and provide concrete best practices that can be learned from and advanced. Following the Youth 2030 session, a cocktail and launch of a Youth 2030 Exhibition which will further profile the amazing work of youth globally on achieving the SDGs. Findings from this event will be forwarded on to the High-Level meeting to be held on April 28<sup>th</sup> in the UN General Assembly.

#### Objective

Youth 2030 Cities is located in cities in six countries – Colombia, Ecuador, Ghana, India, Senegal and Vietnam. The initiative is implemented through a collaboration between Fondation Botnar's Health City for Adolescent programme, UN-Habitat and youth and local government partners in each of the countries. Through research, training workshops, the collection of promising practices, development of digital tools and Youth 2030 forums, the programme supports and empowers youth to become active in achieving the SDGs and NUA. Youth 2030 DeclarACTIONS developed at the forums will be presented by the youth during the event to promote dialogue and youth-led solutions, leading to them being tabled and adopted at World Urban Forum 11 in Katowice, Poland.





The Youth 2030 Cities event is essential space for an inclusive dialogue and sustainable solutions to global urban challenges. As youth are often overshadowed when it comes to decision-making, it is important to create a space where their voices can be heard and where they might improve their capacities so that they can lead the way towards a future that is more sustainable, safe, inclusive, and prosperous.
