Thank you, Madam Chairperson.

Excellencies,

Good morning, good afternoon and good evening.

I welcome all of you to this very first meeting of the CPR Bureau for the period 2021-2023.

SLIDE 3: Congratulations to the CPR Bureau.

Allow me first to congratulate Pakistan, Colombia, and Tanzania for your election to Bureau during the high-level midterm review of the CPR held in June 2021. I also thank WEOG and the Eastern European Group for nominating Belgium and Slovakia as their respective representatives to the Bureau following the high-level mid-term review. This will ensure that the work of this Bureau continues with full and equitable representation of all Member States especially as we head to the second open-ended meeting of the CPR to prepare for the second session of the UN-Habitat Assembly in June 2023.

Madam Chair,

Excellencies,

I want to assure you all of my commitment and that of my team to work closely with you and support you in your role as we prepare and deliver on the open ended meeting of the CPR and the UN-Habitat Assembly itself next year.

<u>SLIDE 4:</u> Item 2. Feedback from the Executive Director on the ECOSOC special meeting and on the high-level meeting of the General Assembly on the progress in the implementation of the New Urban Agenda.

With specific regard to the feedback on the on the ECOSOC special meeting and on the high-level meeting of the General Assembly on the progress in the implementation of the New Urban Agenda, you would recall that I already briefed all Member states on 21 May 2022 and in this regard, I will be quite brief in highlighting some key points.

Let me first thank Members States for their active engagement in the preparatory process leading up to the ECOSCO meeting on 21 April 2022 and subsequently the HLM on 28 April 2022. Permanent Representatives in Nairobi played a crucial role in mobilizing support of their counterparts in New York and senior officials in respective capitals. This contributed to over 87 Member States being inscribed in the HLM, the most well attended meeting of the General Assembly in many years. Thanks for this.

Excellency,

Member States not only came to New York in large numbers, but they also put forth actions and declared commitments as part of their official statements to the HLM. We may want to use the sessions of the Governing Bodies in 2022 and 2023 to show case work by UN-Habitat and its partners to promote four action areas that clearly emerged out of the HLM.

Regarding, <u>affordable and well-serviced housing</u>, many Member States at the HLM called upon the international community for assistance, unable to counter the growing housing deficit and glaring gaps in basic service delivery, to alleviate poverty and social inequality.

Concerning, <u>climate adaptation and mitigation</u>, Member States at the HLM noted that car usage and construction in cities are causing a large share of the global CO₂ emissions, and the effects of climate change are disproportionally affecting the urban poor; and that urban sprawl contributes to environmental degradation and

biodiversity loss. UN-Habitat works with cities to promote resilient and low carbon building and planning standards, resources, and capacity building.

On <u>conflict response</u>, Member States at the HLM emphasized that in 2021 more than 84 million people had been forcibly displaced due to persecution, conflict, violence, human rights violations, and climate change. Many pledged to amplify the implementation of the New Urban Agenda in post-conflict scenarios and for the international development community to provide guidance on post-conflict reconstruction, including urban recovery frameworks.

As regards <u>multi-level governance and localization</u>, Member States emphasized that few local governments are equipped to respond to the multiple crises. UN-Habitat has been actively working with neighborhood organizations, cities, and national governments to improve multi-level urban governance system to localize the SDGs and respond to the complex global political environments.

Distinguished Representatives,

In conclusion, I would like to share with the Bureau my thoughts about how we might utilize other intergovernmental meetings and processes to further the outcomes of the HLM. Clearly the upcoming eleventh session of the World Urban Forum offers governments and other constituencies opportunities to advance the above action areas.

So too do the G7 meeting in Germany, the G20 meeting in Indonesia, COP27 in Egypt, the 2023 opening session of the African Union, the Second Session of the Habitat Assembly, and the 2023 High-Level Political Forum that will feature SDG 11. Strategically we need to utilize these international processes to promote relevant action areas, for example organizing and urban climate track for COP27 with the support of the Prime Minister of Egypt. In addition, I hope to promote the action areas in consultation with the Group of Friends and as Co-Chair of the Local2030 Coalition and the partnership with DCO on Sustainable Urbanization.

In the four key thematic areas I have mentioned, we hope to see the discussions remain active with the governing bodies of the UN-Habitat where we as UN-Habitat will be happy to discuss our work and added value in these core areas, with the possible reinforcements by our partners in the field including mayors and policy makers. I look forward to the support of the CPR in taking forward any

recommendation on housing, climate, conflicts and localization of the SDGs in their preparations for the UN-Habitat Assembly in 2023. It is my hope that at the next meeting of the CPR Bureau I will be able to share with you some of my suggestions for the next open-ended meeting of the CPR and how the UN-Habitat Assembly could look like. The suggestions will be informed by the outcomes of some of the key international meetings we will be having between now and then, including WUF11 and CoP27. We would like to see, for example, how the outcome of WUF11 can shape the theme of the second session of the UN-Habitat Assembly. In addition, I will soon be putting together an internal task force made up of key staff members to advise and help us shape the next open-ended meeting of the CPR as well as the UN-Habitat Assembly next year.

- Monthly Meetings of the Bureau until June 2023 to prepare for the UN-Habitat Assembly.
- 29 May to 2 June 2023: Open-ended CPR meeting.
- 5 to 9 June 2023: Second session of the UN-Habitat Assembly.

We shall have a clear road map by the end of this year, but as is practice, the CPR Bureau is likely to hold monthly meetings in 2023 in preparations for the open-ended meeting of the CPR to prepare for the UN-Habitat Assembly in June 2023.

Madam Chairperson,

We as a Secretariat do not have any proposals to the provisional Agenda at this point. However, I would like to recall the request by the CPR in paragraph 5 of the same decision 2021/4 for me to "to enhance engagement with Member States in the preparation and delivery of future high-level midterm reviews of the Committee of Permanent Representatives, in accordance with the relevant rules of procedure".
