# 2.THE PROVISIONAL AGENDA FOR THE SECOND SESSION OF THE UN-HABITAT ASSEMBLES



# Rule 10, 11 and 12 on drawing up the Provisional Agenda and Supplementary items

- 1.In line with Rule 10.1 of the rules of procedure of the Assembly, The Executive Director already submitted to the UN-Habitat Assembly at its first regular session of 2019 the provisional agenda for the second regular session to be held in June 2023.
- 2. Further, in line with Rule 10.2, the provisional agenda was **also reviewed by the CPR** at its high level midterm in June 2021 **without any changes**.
- 3. However, the provisional Agenda which is to be adopted at the start of the second regular session of the UN-Habitat Assembly is still open for further supplementary items by:
  - a) The UN-Habitat Assembly;
  - (b) States Members of the United Nations and members of the United Nations specialized agencies;
  - (c) The General Assembly;
  - (d) The Economic and Social Council;
  - (e) The Executive Director.
- 4. In line with Rule 12, supplementary items must be presented for inclusion in that agenda not less than 49 days in advance of the opening date of the session, and be examined by the CPR at its preparatory meeting prior to the session. Supplementary items to be presented by 17 April 2023

# 3.PREPARATIONS FOR THE SECOND SESSION OF THE UN-HABITAT ASSEMBLY





# a. Notification by the Executive Director by December 2022 (Rule 8)

- 1. The Executive Director shall send notification of the **date of each session** of the UN-Habitat Assembly and **its provisional agenda** to the following:
- (a) All States Members of the United Nations;
- (b) The chairs of the intersessional organs of the UN-Habitat Assembly, as appropriate;
- (c) The United Nations specialized agencies, related organizations and other United Nations bodies;
- (d) The entities, intergovernmental organizations and other entities referred to in rule 66;
- (e) The organizations referred to in rules 67 and 68 and other relevant stakeholders.
- 2. The notification shall be addressed to the President of the General Assembly, the President of the Economic and Social Council and the organizations and institutions referred to in rule 68.
- 3. The notification for a regular session, be sent in the official and working languages of the UN-Habitat Assembly, **not less than 6 months prior to the opening of the session.**
- 4. Notification and Agenda for the second session must therefore be ready by end of October 2022 for editing and translation in time for distribution by 31 December 2022.

# b. Some key timelines in the roadmap to the UN-Habitat Assembly

- 018 October 2022: Recommendation of theme of the second session by the Joint Bureaux of the Governing Bodies.
- **31 October 2022:** Submission to the Division of Conference Services the Notification and Provisional Agenda for editing and translation.
- O31 December 2022: Transmission of the Notification of the Executive Director and provisional Agenda in all six languages to Member States and key organs of the United Nations and partners.
- oFebruary 2023: Invitations to high level Government officials for the second session of the Assembly, particularly Ministers of Foreign Affairs and line Ministers.
- oEnd of March 2023- Early April 2023: First session of the Executive Board for the year 2023 with possible recommendations for the UN-Habitat Assembly.
- OApril 2023: Transmission of pre-session documents for the UN-Habitat Assembly to all Member States in all languages.
- OApril 2023: Final submission of supplementary items to the provisional Agenda of the session in line with Rule 10.3 for further consideration by the CPR.
- 029 May 3 June 2023: Open-ended meeting of the CPR to prepare for the second session of the UN-Habitat Assembly.

# c. Theme of the second session of the UN-Habitat Assembly by 31 October 2022

- 1. The choice of the **theme** of the second session should be **guided by Resolution 20/21** of the former Governing Council which requires the theme **to be selected by the Bureau at least six months** before the start of each **on the basis of advice from the Executive Director** taking into account the outcome of the sessions of the World Urban Forum and other key international meetings, including the High Level Meeting of the General Assembly to assess the progress in implementation of the New urban Agenda.
- 2. The theme is part of the Notification of the Executive Director which needs to be finalized by end of October 2022 in time for editing and translation by end of December 2022.
- 3. As such work on proposal for the **theme** of the second session **has begun** and requires the recommendation of the Bureau.









# **UN-Habitat resource mobilization overall progress (2020 – 30 Sep 2022)**



# **2022 Financial Performance** (as of 30 September 2022)






#### Outcomes

- In 2022, only 25% of foundation non-earmarked secured leaving a 9-million-dollar gap.
- Regular budget has achieved 77% of it budget of 2022 as of 30 September, which is well on track.
- Technical cooperation acquired 50% of its budget as of 30 September 2022.



#### Results

- Identified priority countries in which UN-Habitat country offices work with UNCT to conduct Common Country Assessments, to make sure that the urban dimension is well heard and incorporated in joint programmes of the UN. This underpins the resource mobilization efforts in countries.
- As a result of the funding dialogues, 5 new donors and 2 comeback donors have made contributions to UN-Habitat core funds. 10 countries have made pledges totalling USD 10.5 million in 2022.
- Exploring and implementing new partnership initiatives, such as the programme office to be established in Montreal Canada.

- 11 of the top 15 donors in 2022 are from local governments, foundations and philanthropies, UN, academia, pooled funds or civil society, showing a diversified donor base
- Work with the Sustainable Human Settlements Foundation to mobilise resources from the private sector and sovereign wealth funds
- Commitment from the Foundations and Philanthropy Platform to establish a Feasibility Fund as part of the City Investment Facility.

#### Results

# Resource mobilization roadmap

#### **September – October**

- Organize the 1st meeting for the Informal Contact Group on Resource Mobilisation
- Strategic communications with key donors
- Leverage Urban October to support the resource mobilization efforts in countries and regions



#### **January 2023**

- Communicate with Member States about the workprogramme and budget of 2023 as well as sending the the reminder for core contributions

#### November – December

- Covert pledges into cash
- Transition from soft-earmarked to core contributions
- Send core contribution letters



#### February – May

Engagement with non-state donors (private sector, foundations, banks) to diversify donor base

#### June - UN-Habitat Assembly

Host a pledging session with a target of **50 Member States** to contribute to the core funding
