Report of the Executive Director

I. Introduction

1. The present report presents the staffing situation at the United Nations Human Settlements Programme (UN-Habitat) as at 30 June 2022. In addition to the information on posts by source of funding set out below, annex I to the present report sets out the distribution of UN-Habitat staff by nationality, grade and gender. Annex II sets out the distribution of staff by regional group while annex III provides a summary of the distribution of all staff by duty station and category.

II. Overview

- 2. Table 1 presents the status of post occupancy at UN-Habitat for posts funded by non-earmarked and earmarked funds as at 30 June 2022. There were a total of 212 approved posts under the non-earmarked category, comprising 205 regular posts and 7 general temporary assistance posts. Of the approved posts, 130 were occupied, representing an occupancy rate of 61.3 per cent and comprising 77 Professional posts and 53 General Service posts. Occupied posts comprised 124 regular posts and 6 general temporary assistance posts. Under the earmarked category, a total of 173 posts were occupied, comprising 115 posts funded by Foundation earmarked funds and 58 funded by technical cooperation funds. 12 of the Foundation earmarked posts were for Junior Professional Officers, as is detailed in table 3.
- 3. Table 2 shows the distribution of UN-Habitat staff by source of funding and grade as at 30 June 2022, while the figure on page 3 shows staff distribution by grade and gender.




