IMPLEMENTING THE NEW URBAN AGENDA

Following consultations with the UNON Division of Conference Services and taking into account the UN global calendar, it is recommended for the Bureau's consideration that:

- 1. The second session of the Executive Board in 2023 be held for half a day, on the margins of the second session of the UN-Habitat Assembly in June 2023 and in a manner that does not conflict with the plenary meetings of that session of the UN-Habitat Assembly.
- 2. The third session of the Executive Board should take place from 7 to 9 November 2023, avoiding any conflicts with COP28. But in the event that the COP 28 dates are changed we could work with the dates of 27 to 29 November 2023
