#### **Introductory remarks:**

Excellencies,

Distinguished Delegates,

- It is my distinct pleasure to welcome you all to the first meeting of the Bureau of the UN-Habitat Assembly for the year 2023. This being our very first Bureau meeting for this year and even if a bit late, allow me to wish all of you a very happy new year.
- Let me start by offering my condolences to the families of the victims, the Governments, and the people of Türkiye and of Syria following the earthquake on Monday, 6 February 2023.
- I am very excited to work with all of you in the upcoming months, to deliver a successful second session of the UN-Habitat Assembly.
- My gratitude for the presence of the Bureau Members at this meeting. I thank you for the good work you have been doing since the establishment of the Assembly.
- In that respect and with your permission, I wish to take note of the presence of:
  - Your Excellency, Ms. Saqlain Syedah Permanent Representative of the Islamic Republic of Pakistan to UN-Habitat, Chair of the Committee of Permanent Representatives to UN-Habitat for 2021-2023. Thank you for your leadership in our obligation to guide the Organization.
  - I wish to also thank the distinguished members of the Bureau of the UN-Habitat Assembly and of the Bureau of the CPR for the support to the Chair in carrying out her duties.

# Statement of President of the UN Assembly:

- In my capacity as President of the Assembly, I would like to emphasize the importance of this meeting, which brings us together today, and the responsibility of continuing to offer innovative solutions to the world through the Sustainable Development Goals and the New Urban Agenda. # Agenda item 2: General update on status of preparations of the second session of the UN-Habitat Assembly

- You would recall that the second session of the UN-Habitat will be held from 5 to 9 June 2023, and pursuant to paragraph 7 of Decision 1/3, the first session of UN-Habitat Assembly also decided on the provisional Agenda for its second session which was further reviewed by the Committee of Permanent Representatives to UN-Habitat, during its first open-ended meeting for a high-level mid-term review. The provisional Agenda was also reviewed and confirmed during our Joint Bureaux meetings held on 29 June and 18 October 2022.
- I now give the floor to the Executive Director who will brief us on the status of preparations of the second session of the UN-Habitat Assembly. After the briefing by the Executive Director, I will then open the floor for discussion and invite the Bureau to make comments and recommendations.

# D) Recommendation for the submission of draft resolutions

Distinguished Delegates,

- Notwithstanding the fact that it is the prerogative of any Member State to introduce a resolution at the Assembly, it is crucial that we provide clear guidance as a Bureau for the submission of resolutions, including a timeline for such submission. I indeed foresee that our guidance would allow a very seamless transition from the open-ended meeting of the CPR (OECPR) to the Assembly. It is expected that those resolutions will be formally considered by the OECPR following which the Chair of the CPR will forward the drafts in their most updated version to me as the President of the UN-Habitat Assembly for consideration by the Assembly.

- Excellencies, Distinguished Delegates, we heard from the Executive Director that Rule 23.2 provides for the possibility of the CPR to establish a subcommittee to efficiently implement its mandate.
- I would strongly support, in my capacity as President of the UN-Habitat Assembly and on the basis of consensus, the establishment of such subcommittee by the CPR at its next open-ended meeting in preparation of the second session of the UN-Habitat Assembly. The subcommittee would indeed be instrumental in the future in considering

draft resolutions and in providing a framework both to Member States and to the Secretariat for the preparations towards the meetings of the CPR and sessions of the UN-Habitat Assembly.

Agenda item 3 : Vacant position of Rapporteur in the Bureau of the CPR for 2021-2023, preparations for the elections of the members of the Executive Board for the term 2023-2027 and officers of the 2023-2027 Bureau of the UN-Habitat Assembly

## Vacant Position of Rapporteur in the Bureau of the CPR for 2021-2023

#### Excellencies,

Distinguished Delegates, let me provide a little background on this Agenda Item.

- Pursuant to Rule 27 of rules of procedure of the UN-Habitat Assembly, the Bureau of the CPR was elected at the end of the high-level mid-term review meeting held in June 2021.
- The composition of the elected Bureau was as follows:

- Chair: Pakistan
- Vice-Chairs: Tanzania and Colombia. One position of Vice-Chair remained vacant pending the nomination of the representative of Western European and other States (WEOG).
- Rapporteur: The position of Rapporteur remained vacant pending the nomination of the representative of Eastern Europe.
- The CPR elected the members of the Bureau on the understanding that it would have an opportunity, on a no objection basis, to elect the remaining members of the Bureau upon nomination by the regional groups.
- On 13 October 2021, the Chair of WEOG informed the Secretariat of the nomination of Belgium for the position of Vice-Chair of the CPR Bureau.
- On 15 November 2021, the Chair of the Regional Group of Eastern European States informed the Secretariat of the nomination of Slovak Republic for the position of Rapporteur of the CPR Bureau.
- On 16 June 2022, and after consultation with the Bureau on 15 June 2022, the Secretariat circulated a letter on behalf of the Chair of the CPR inviting all Member States to approve the respective nominations on a no objection basis.
- On 21 June 2022, the Secretariat received an email from the Russian Federation informing of the Country's objection to the nomination of Slovakia to the position of Rapporteur.
- Referring to the CPR Bureau meeting on December 1, 2022, one of the options considered was that the Eastern European Group switch the office of Rapporteur with another Regional Group where the position of Rapporteur will be assumed by another Regional Group, and the Eastern European Group would assume the position as Vice Chair instead.
- Let me give the floor to the Secretariat Government Bodies to explain to us how this will work. But before that does the CPR Chair wish to take the floor on this.?

## Elections of the members of the Executive Board

• In line with rule 7 of the rules of procedure of the Executive Board, the Executive Board shall consist of 36 Member States, to be elected by the UN-Habitat Assembly in accordance

with the following criteria: 10 seats for African States; 8 seats for Asia-Pacific States; 4 seats for Eastern European States; 6 seats for Latin American and Caribbean States; and 8 seats for Western European and other States. The members of the Executive Board hold office for a term of four years commencing with their election during a session of the UN-Habitat Assembly.

- I invite all regional groups to start caucusing towards nominations for their respective representatives to the Executive Board for 2023-2027.
- I now open the floor for reaction by the Bureau.

# Election of the Bureau of the UN-Habitat Assembly for 2023-2027

  - Vice-Presidents: African States, Eastern European States, Western European and other States
