#### THE WORLD WILL BE URBAN

Today <u>55% of the world's population lives in cities</u>, yet by 2050 this is expected to increase to 68%

#### **CITIES ARE CENTRAL TO SDGs**

- SDG Cities is a global initiative that encourages cities to catalyze their own potential and accelerate their achievement of the Sustainable Development Goals (SDGs)
- Cities are given tools to assess their baseline data and identify and implement priority initiatives that actively localize the SDGs





# **Need** for cities to step up the realization of their *transformative potential* as a positive force for sustainable development

#### However

- Not all cities are aware of the SDGs
- > Not all cities are incentivized to engage with global agendas
- > Not all cities are aware of frameworks such as the NUA to guide them in the local implementation of the SDGs


### **Purpose** of SDG Cities Certification

SDG Cities certification helps set cities on the course to accelerate achieving the Sustainable Development Goals by:

- Guiding an effective urban development process, in line with the New Urban Agenda
- Recognizing the achievement of key milestones and inclusive, effective processes via the completion of objectives

#### Other areas being explored:

- Improving multi-level policy coherence
- Improving UN coordinated action at the local level
- Alignment with SDG accreditation and support of other organisations
- Alignment with "creditworthiness" metrics
- Alignment with ESG metrics of financers
- Aggregated investments

### **Certification Stages**

**1.** Cities have effective data for social, economic and environmental dimensions with analyzed gaps in urban areas and have evidence-based, inclusive, participatory and strategic development frameworks for 2030 that:

- Are aligned with the 2030 Agenda;
- Are aligned with local development priorities;
- Are coherent with relevant national, subnational, cross-border and sectoral policies and priorities.

2. Cities are effective "drivers of change": They have taken stock of their governance, and revenue systems, plans and regulations and assessed the performance of key basic urban services and have demonstrated progress in strengthening them


3. Cities are generating measurable SDG impact

### **Alignment with UN Agendas and Frameworks**

SDG Cities Certification is strongly aligned with existing UN agendas to accelerate the achievement of SDGs and facilitate a positive urban transformation



### **Synergies within UN- Habitat**



SDG Cities Certification connects existing UN-Habitat projects and tools, creating a powerful combination for SDG Localization.

UN-Habitat country programmes are well positioned to provide technical support to cities

### **Piloting Model - Global Mechanism**

#### **Global Mechanism for Implementation**

#### **Global Advisory Committee**

Role

- Setting rules and criteria
- Guiding the establishment of national mechanisms

#### Pilot Stage

UN-Habitat senior staff agree on certification criteria in consultation with UN Member States and Partners

#### Long Term

- Advisory board of UN partner entities and UN Member States
- Engagement with ECOSOC Accredited stakeholders agreed by UN MS

#### **Technical Team**

Role

- Review applications cities in countries that lack a national mechanism
- Identify areas for action
- Monitoring/ auditing certification

#### Pilot Stage

Technical support provided through SDG Cities Global Flagship Initiative

#### Long Term

Creation of national technical hubs for independent technical backstopping

### **Piloting Model - National Mechanism**

#### National Mechanism for Implementation

### National Advisory Committee

#### Role

Adapt criteria to national context and develop priorities and to implement certification

#### Pilot Stage

A collection of ministries provide in-kind services to support the certification of a cluster of cities

#### Long Term

- Establish a national hub to regularly review and report on the certification for cities
- Global engagement and peer-to-peer learnings

#### **Technical Team**

#### Role

- Establishing technical team to review applications and make recommendations on certification
- Optional- Establish a technical support hub for cities

#### Pilot Stage

Technical support is provided jointly between national staff and SDG Cities Global Initiative staff

#### Long Term

Establish technical team to assist with certification criteria (data collection, etc.) in cities

### **Piloting Model - Support Services**



#### **Digital Platform**

Provided through an in-kind donation for technical support and data storage

### **Estimated Funding Requirement**

#### **Global Hub**

Initially US\$1. 5 million per year, that may gradually increase or replicated at regional levels as certification goes to scale

- Time and travel of Global Advisory Committee, meeting annually
- Secretariat team supporting the Global Advisory Committee,
- Global Technical Team working in UN Languages
- Digital platform maintenance

Cost recovery may be applicable for certification processes managed by the Global Hub in middle/upper income countries

#### **National Mechanism**

• National lead entity to designate National Advisory Committee and technical team

• Digital Platform, technical and monitoring tools and backstopping provided in-kind by global hub Where SDG Cities National Programmes are implemented with donor support (eg Ghana), national certification mechanisms are incorporated into costs

### **Possible Benefits**

#### **For Cities**

- Incentivizing the acceleration of the SDGs
- Providing direction
- Enabling knowledgesharing and capacity development at scale
- Attracting SDG aligned investment
- Coherence with other city-based initiatives that support global agendas

#### **For Residents**

 Certification promotes a greater responsiveness of cities to the needs of residents in cities

#### **All of Society Coherence**

- Multi- stakeholder coherence around implementing the SDGs in cities
- Aggregating SDG investment for greater efficiency

#### For the UN System

 Promotes local implementation of the UN Cooperation Framework and the integration of United Nations system support at the local level

#### For National and Subnational Governments

• Policy coherence
