**Item 1**

**Opening of the session**

1. On 20 December 2018, the General Assembly of the United Nations, in resolution 73/239, decided to dissolve the Governing Council of the United Nations Human Settlements Programme (UN-Habitat) and to replace it with the United Nations Habitat Assembly of the United Nations Human Settlements Programme (UN-Habitat Assembly), comprising universal membership.
2. In the same resolution, the General Assembly welcomed the work of the Open-ended Working Group established by the Chair of the Committee of Permanent Representatives to UN-Habitat pursuant to General Assembly resolution 72/226 and endorsed the findings and recommendations of the Open-ended Working Group on changing the governance structure of UN-Habitat.
3. The UN-Habitat Assembly held its first session from 27 to 31 May 2019 pursuant to resolution 73/239 of the General Assembly.
4. During that session, the Assembly adopted its rules of procedure as prepared by the Committee of Permanent Representatives, endorsed the rules of procedure of the Executive Board of UN-Habitat, and elected 36 members to the Executive Board and to the Bureau of the Committee of Permanent Representatives.
5. The UN-Habitat Assembly adopted the following resolutions and decisions at its first session:
  - (a) Resolution 1/1: United Nations Human Settlements Programme strategic plan for the period 2020–2023 (HSP/HA.1/Res.1);
  - (b) Resolution 1/2: United Nations System-Wide Guidelines on Safer Cities and Human Settlements (HSP/HA.1/Res.2);
  - (c) Resolution 1/3: Enhancing capacity-building for the implementation of the New Urban Agenda and the urban dimension of the 2030 Agenda for Sustainable Development (HSP/HA.1/Res.3);
  - (d) Resolution 1/4: Achieving gender equality through the work of the United Nations Human Settlements Programme to support inclusive, safe, resilient and sustainable cities and human settlements (HSP/HA.1/Res.4);

- (e) Resolution 1/5: Enhancing urban-rural linkages for sustainable urbanization and human settlements (HSP/HA.1/Res.5).
6. The Assembly also adopted a ministerial declaration entitled “Innovation for better quality of life in cities and communities: accelerated implementation of the New Urban Agenda towards the achievement of the Sustainable Development Goals” (HSP/HA.1/HLS.1).
7. In addition, the Assembly adopted the following decisions:
- (a) Decision 1/1: Rules of procedure of the United Nations Habitat Assembly (HSP/HA.1/HLS.2);
- (b) Decision 1/2: Rules of procedure of the Executive Board of the United Nations Human Settlement Programme (HSP/HA.1/HLS.3);
- (c) Decision 1/3: Arrangements for the transition towards the new governance structure of the United Nations Human Settlements Programme (see document A/74/8).
8. The report of the UN-Habitat Assembly on the work of its first session is set out in document A/74/8.
9. The provisional agenda of the session, as set out in decision 1/3 of the UN-Habitat Assembly and further reviewed by the joint bureaux of the governing bodies of UN-Habitat under the leadership of the President of the Assembly, is set out in document HSP/HA.2/1.
10. It is anticipated that the session will be opened at 9 a.m. on Monday, 5 June 2023.
11. Under item 1 of the provisional agenda, the President will declare the second session of the UN-Habitat Assembly open and outline the procedures for the session.

### **Item 2**

#### **Adoption of the agenda**

12. Under this item, the UN-Habitat Assembly will adopt the agenda for its second session and thereafter decide on the organization of work for the session. The provisional agenda was approved by the UN-Habitat Assembly at its first session, held in Nairobi from 27 to 31 May 2019.

### **Item 3**

#### **Report of the Chair of the Committee of Permanent Representatives**

13. In line with resolution 73/239 and rule 23 of the rules of procedure of the UN-Habitat Assembly, the Committee of Permanent Representatives met for its first open-ended meeting, for a high-level midterm review, in June 2021 and is scheduled to meet for its second open-ended meeting, to prepare for the second session of the UN-Habitat Assembly just prior to that session, from 29 to 31 May and on 2 June 2023.

14. Under this item, the UN-Habitat Assembly will adopt the report of the Chair of the Committee of Permanent Representatives.

**Item 4****Credentials of representatives**

15. Each Member State of the UN-Habitat Assembly should be represented by an accredited representative, who may be accompanied by such alternate representatives and advisers as may be required by the Member State. The credentials of representatives and the names of alternate representatives and advisers should be submitted to the Executive Director at the latest before the end of the first meeting of the session, which will be held on 5 June 2023. The credentials must be issued either by the Head of State or Government or by the Minister for Foreign Affairs. The credentials submitted under this rule will be examined by the Bureau of the UN-Habitat Assembly, which will report without delay to the Assembly.

**Item 5****Election of the members of the Executive Board**

16. Under this item, the UN-Habitat Assembly will elect the 36 members of the Executive Board for a term for the period 2023–2027 in accordance with the formula set out in document A/73/726 and in rule 24 of the rules of procedure of the UN-Habitat Assembly. The distribution of seats on the Board is to be as follows: 10 seats for African States, 8 seats for Asia-Pacific States, 4 seats for Eastern European States, 6 seats for Latin American and Caribbean States, and 8 seats for Western European and other States. Following the election of the 36 members of the Executive Board by the UN-Habitat Assembly and in line with rule 9 of the rules of procedure of the Executive Board, the election of the Bureau of the Executive Board for the period 2023–2024 will take place on the margins of the first session of the UN-Habitat Assembly, specifically on Thursday, 8 June 2023, and as recommended by the Bureau of the Executive Board during its meeting held on 8 February 2023. The elections for the Bureau of the Executive Board will be conducted with due regard to the principle of equitable geographical distribution by rotation among the regional groups of States. The Bureau will be composed of a chair, vice-chairs and a rapporteur.

**Item 6****Adoption of the report of the Executive Board**

17. During its first session, which took place from 27 to 31 May 2019, and in line with resolution 73/239, the UN-Habitat Assembly adopted its rules of procedure, elected 36 of its members to serve on the Executive Board of UN-Habitat and endorsed the rules of procedure of the Executive Board.

18. Following the election of its 36 members, the Executive Board held its first meeting on the margins of the first session of the Assembly and elected its Bureau.

19. The Executive Board has since met at least two times every year.

20. Under this item, the UN-Habitat Assembly will adopt the report of the Executive Board on its intersessional work.

**Item 10****Dialogue on the special theme for the second session of the United Nations Habitat Assembly**

24. In accordance with the relevant paragraphs of Governing Council resolution 20/21, set out in annex I to the present document, the special theme of the second session of the UN-Habitat Assembly is “A sustainable urban future through inclusive and effective multilateralism: achieving the Sustainable Development Goals in times of global crises”.
25. The UN-Habitat Assembly will have for its consideration a report by the Executive Director on the special theme of the second session.
26. During the session, there will be a dialogue on the theme of the UN-Habitat Assembly among national Governments, subnational governments, and other Habitat Agenda partners.

**Item 11****Strategic plan of UN-Habitat for the period 2024–2027**

27. At its first session, held in May 2029, the UN-Habitat Assembly adopted the UN-Habitat strategic plan for the period 2020–2023 in resolution 1/1. The period covered by the strategic plan will end on 31 December 2023.
28. The Executive Board, in paragraph 14 of decision 2021/6, recommended that the UN-Habitat Assembly at its second session of 2023 consider approving the extension of the current strategic plan for the period 2020–2023 until 2025 to cover the period 2020–2025, in order to align the planning cycle of UN-Habitat with the quadrennial comprehensive policy review.
29. In addition, in paragraph 16 of decision 2021/6 the Executive Board requested the Executive Director to prepare a new comprehensive options paper, in line with General Assembly resolution 73/239 of 20 December 2018 and the relevant rules of procedure, to consider ways of approving the strategic plan for the period 2026–2029 and the implications thereof for the subsidiary bodies of the UN-Habitat Assembly, and present it to the Assembly for its consideration at its second session of 2023.
30. The UN-Habitat Assembly may therefore consider the extension of the current strategic plan to cover the period 2020–2025, based on the recommendation of the Executive Board to allow UN-Habitat to align its planning cycles with the quadrennial comprehensive policy review and given that a new strategic plan has not been prepared by the Executive Board.

**Item 14**

**Election of officers**

33. Under this item and in line with rule 18 of the rules of procedure of the UN-Habitat Assembly, the UN-Habitat Assembly will elect a president, three vice-presidents and one rapporteur from among the representatives of its members, with due regard to the principle of equitable geographical distribution by rotation among the regional groups of States.

34. In line with rule 18, the UN-Habitat Assembly shall ensure that each of the five regional groups is equally represented in the Bureau. In addition, the five members of the Bureau of the Committee of Permanent Representatives will jointly serve as additional vice-presidents of the Bureau of the Assembly and no two members of the Bureau of the UN-Habitat Assembly shall be from the same Member State, and it shall be constituted so as to ensure its representative character.

35. Annex II to the present document shows the geographical distribution of the Bureau members elected at the first session of the Assembly and the expected geographical distribution of the incoming Bureau of the Assembly to be elected on the final day of the second session.

## Annex I

### Resolution 20/21: Organization and themes for future sessions of the Governing Council

*The Governing Council,*

*Recalling* its resolution 5/15 of 7 May 1982, in which it decided to designate the subjects of the special themes of its sessions two years in advance,

*Also recalling* its resolution 16/12 of 7 May 1997, in which it decided to provide, at future sessions of the Council, opportunities for partners to engage in a dialogue among themselves and with Governments,

*Further recalling* its resolution 19/5 of 9 May 2003, in which it decided that a continuing focus of its twentieth and future sessions should be the implementation and monitoring of the goal of the United Nations Millennium Declaration<sup>1</sup> on improving the lives of slum dwellers,

*Noting* that the World Urban Forum now provides an opportunity for extensive dialogue among Governments, local authorities and other Habitat Agenda partners,

*Recognizing* the importance during sessions of the Governing Council of a focused, interactive high-level segment on priority policy issues,

1. *Endorses* the recommendations of the Committee of Permanent Representatives on improving preparations for the Governing Council, which are contained in the appendix to the present resolution;
2. *Decides* that the special themes referred to in resolution 5/15 shall no longer be chosen two years in advance, but shall instead be selected by the Bureau of the Governing Council at least six months before the start of each session of the Governing Council, on the basis of advice from the Executive Director, in consultation with the Committee of Permanent Representatives, taking into account the outcome of the sessions of the World Urban Forum and the requirement for a continuing focus on the implementation and monitoring of the goal of the Millennium Declaration on improving the lives of slum dwellers;
3. *Also decides* that the high-level segment and the dialogues referred to in its resolution 16/12 should normally focus on those special themes and should constitute the substantive debate on the special themes;
4. *Requests* the Committee of Permanent Representatives to recommend to the Governing Council at its twenty-first session, through the Bureau of the Governing Council, further proposals for improving the structure and organizational arrangements of the twenty-first and future sessions of the Governing Council including, in particular, the high-level segment;
5. *Requests* the Executive Director to prepare a background paper for use by the Committee of Permanent Representatives in complying with the request set forth in the preceding paragraph.

## Annex III

### Proposed organizational arrangements

1. For the efficient conduct of work during the second session of the United Nations Habitat Assembly of the United Nations Habitat Settlements Programme (UN-Habitat Assembly), the Executive Director proposes for consideration by Member States the proposed organizational arrangements and timetable set out in annex IV to document HSP/HA.2/1/Add.1. This proposal has been prepared in line with the general practice at the first session of the UN-Habitat Assembly and is subject to further review by the Bureau of the UN-Habitat Assembly, as well as by the Committee of Permanent Representatives during its second open-ended meeting, to be held from 29 May to 2 June 2023 to prepare for the second session of the UN-Habitat Assembly.

#### A. Bureau

2. In accordance with rule 18 of the rules of procedure, the Bureau of the UN-Habitat Assembly will comprise a president, vice-presidents and a rapporteur elected with due regard to the principle of equitable geographical distribution by rotation among the regional groups of States. Annex I to document HSP/HA.2/1/Add.1 shows the geographical distribution of the Bureau members elected at the first session of the Assembly and the expected geographical distribution of the incoming Bureau of the Assembly to be elected on the final day of the second session. For information purposes, the composition of the bureaux of the governing bodies of UN-Habitat is available at <https://unhabitat.org/governance/un-habitat-assembly#Governance-UNHabitatAssembly-compositionofthebureau>.

3. As provided for in rule 18 of the rules of procedure of the UN-Habitat Assembly, the five members of the Bureau of the Committee of Permanent Representatives will jointly serve as additional vice-presidents of the Bureau of the Assembly.

#### B. Plenary

4. Following previous practice, it is recommended that work in the plenary meetings be divided into two segments: a high-level segment, to be held on the first and second days of the session, and a dialogue among national Governments, subnational governments and other Habitat Agenda partners, to be held on the third day. Part of the morning meeting on the first day will be devoted to organizational matters, including the election of 36 members of the Executive Board.

#### C. High-level segment

5. It is expected that the second session of the UN-Habitat Assembly will include a high-level segment focusing on the theme for the session and matters related to the provisional agenda, such as item 7 of the provisional agenda, on the activities of UN-Habitat, including coordination matters; item 8, on a review of progress in the implementation of the New Urban Agenda and the 2030 Agenda for Sustainable Development; and item 11, on the strategic plan of UN-Habitat for the period 2024–2027.

6. To accommodate the many delegations expected to attend the second session of the UN-Habitat Assembly, it is recommended that, during the high-level segment, each delegation be allowed a maximum of five minutes of speaking time, and that this limit be strictly adhered to.

7. In establishing the list of speakers for the high-level segment, precedence will be given to Heads of State and Government, ministers and deputy ministers. They will be followed by other heads of Government delegations and then by a limited number of representatives of subnational governments, other Habitat Agenda partners and other stakeholders, in accordance with rules 66 and 67 of the rules of procedure of the UN-Habitat Assembly.

#### D. Dialogue with local authorities and other partners

8. It should be recalled that in paragraph 2 of its resolution 16/12, the Governing Council decided to provide, at future sessions, opportunities for partners to engage in a dialogue among themselves and with Governments. Such dialogue may, as appropriate, serve as an input to the deliberations of the second session of the UN-Habitat Assembly.

9. In accordance with the relevant paragraphs of Governing Council resolution 20/21, the theme of the second session is “A sustainable urban future through inclusive and effective multilateralism: achieving the Sustainable Development Goals in times of global crises”.

10. With a view to increasing the participation in and contribution of subnational governments and other partners to the work of the UN-Habitat Assembly, and attaining common goals to achieve the implementation of the New Urban Agenda, the 2030 Agenda for Sustainable Development and the Sustainable Development Goals, arrangements have been made for the dialogue with subnational governments and other partners to be held during the morning plenary meeting on the third day of the session, as indicated in the proposed organization of work and timetable for the second session of the UN-Habitat Assembly (see annex IV to document HSP/HA.2/1/Add.1).

11. To that end, subnational governments and other partners are encouraged to submit to the secretariat, before the start of the session, their statements in writing for advance distribution to all participants.

12. It should also be recalled that Governing Council resolution 20/21 (see annex II to document HSP/HA.2/1/Add.1) provided that the theme of the dialogue should establish a link between the high-level segment and the dialogue among Governments, subnational governments and other Habitat Agenda partners, and should provide for cohesion in the policy discussions during plenary meetings.

13. It is expected that the statements given by representatives of subnational governments and other partners will be the outcome of consultations by those groups with non-governmental organizations, parliamentarians, the private sector, professionals, researchers and other partners. Arrangements will be made for subnational governments and other partners, should they so wish, to hold consultations in Nairobi immediately prior to the session.

14. Detailed information on the organization of the dialogue will be forthcoming.

#### **E. Summary by the President**

15. At the end of the high-level segment and the dialogue, the President of the UN-Habitat Assembly, drawing on the deliberations of the two plenary meetings, will prepare a summary of the main issues raised during the high-level segment and the conclusions or recommendations made during the dialogue. That summary will reflect the main thrust of the discussions and key positions set out during the high-level segment and the dialogue and will be submitted for endorsement during plenary meetings. Any draft resolution that may emerge from the discussions in those plenary meetings will be referred to the drafting committee for action.

16. Once endorsed by the UN-Habitat Assembly as an accurate reflection of discussions during the high-level segment and the dialogue, and after completion of the required legislative process, the conclusions and recommendations of the President of the UN-Habitat Assembly will serve as guidelines for follow-up action by Governments, subnational governments and other partners, and the secretariat, specifically to support activities in the current areas of focus for the current strategic plan, work programme and budget.

#### **F. Sessional organs, subcommittees or working groups**

17. In line with rule 26 of the rules of procedure, during the session the UN-Habitat Assembly may set up other sessional organs, subcommittees or working groups as it may deem necessary and refer to them any item on the agenda or any other question for consideration and reporting.

##### **1. Sessional committee of the whole**

18. Bearing in mind the organization of work of the first session of the UN-Habitat Assembly and the above-mentioned recommendations on work in plenary meetings, the Assembly may wish to establish a sessional committee of the whole to be accorded responsibility for the detailed consideration of items 7, 8, 9 and 11 of the provisional agenda.

##### **2. Drafting committee**

19. At its first session, on an informal basis, the UN-Habitat Assembly established an ad hoc open-ended drafting committee, chaired by one of the vice-presidents, to pre-screen draft resolutions submitted by delegations with a view to merging, reconciling or clarifying them, as necessary, prior to their consideration by the Assembly in a plenary meeting. The Assembly may wish to continue this practice, which was widely considered to have enhanced the efficiency of its work, with the report of the drafting committee being considered by the committee of the whole for endorsement prior to consideration and possible adoption by the Assembly.

**G. Programme and main activities of the second session**

20. In addition to the key issues to be discussed during the second session of the UN-Habitat Assembly, a range of activities are expected to take place, including side events and exhibitions. A programme of official high-level and side events will be prepared by the secretariat under the guidance of the Bureau of the UN-Habitat Assembly and shared in a timely manner prior to the session.

**Annex IV****Proposed organization of work and timetable for the second session of the United Nations Habitat Assembly, 5–9 June 2023**
