Policy Review process (QCPR)".

Agenda item 3: Briefing and discussion on the alignment of the UN-Habitat planning cycles and cycle of election of the offices of the governing bodies with the Quadrennial Comprehensive Policy Review process (QCPR)".

Excellencies,

Distinguished Delegates,

- Let me provide a little background on this Agenda Item before the Secretariat
  shares with us the scenarios associated with the upcoming elections to be
  held during the second OECPR and during the second session of the United
  Nations Habitat Assembly. I believe this is important for putting our
  discussion on this item into context.
- You would recall that the acronym "QCPR" is shorthand for General Assembly Resolution 71/243 on the quadrennial comprehensive policy review of the operational activities for development of the United Nations system. This is the first cycle, 2021-2024, of the mechanism through which the General Assembly assesses the effectiveness, efficiency, coherence, and impact of UN operational activities for development and establishes system-

wide policy orientations for the development cooperation and country-level modalities of the UN system in response to the evolving international development and cooperation environment. As such, the QCPR is the primary policy instrument of the General Assembly to define the way the UN development system operations to support program countries in their development efforts.

- Accordingly, and immediately following the above General Assembly resolution on the QCPR, the Secretary-General promulgated a series of internal documents to guide the Secretariat to implement the operational paragraphs of the QCPR. These inform efforts by the Secretariat and UN entities to develop their respective strategic plans such that these are in line with and help to ensure effective implementation of the QCPR. Currently, UNDP, UNICEF, UNFPA, and most of the UN entities are implementing strategic plans for the period 2022-2025.
- It is anticipated that for the next cycle of the QCPR, the General Assembly at its 79th session in 2024 will adopt a resolution on the QCPR for the period 2025-2028.
- They anticipate implementing subsequent strategic plans for the period 2026-2029 once these are adopted by their respective governing bodies in 2025. Accordingly, it is imperative that UN-Habitat aligns its Strategic Planning cycle with the cycle of the QCPR and the earlier the better and this would have to be in 2025.

- You would recall that at its first session in June 2019, the United Nations
   Habitat Assembly noted the need to align the strategic planning processes of
   UN-Habitat with future iterations of the QCPR and requested the Executive
   Board of UN-Habitat to recommend a way forward.
- You would further recall that the Executive Board, in its Decision 2021/6 paragraph 14, recommended that the United Nations Habitat Assembly at its second session of 2023 consider approving an extension of the current strategic plan for the period 2020–2023, to end in 2025 to cover the period 2020–2025 in order to align the planning cycle of UN-Habitat with the quadrennial comprehensive policy review.
- The United Nations Habitat Assembly will therefore consider at the upcoming second session to be held in June 2023 the extension of the current Strategic Plan to cover the period 2020 to 2025, based on the recommendation of the Executive Board and also to enable the Organization to align with the QCPR process.
- I am aware that when the Bureau of the CPR met on 12 April 2023 it requested the Secretariat to develop scenarios on the alignment of the UN-Habitat strategic planning cycles, with the Quadrennial Comprehensive Policy Review process (QCPR) and election of the offices of the governing bodies.
- Subsequently, at its meeting held on 20 April 2023, the Bureau of CPR further considered scenarios prepared by the Secretariat towards a possible alignment. At that meeting, the Bureau recommended that the alignment of

UN-Habitat planning cycles with the QCPR and election of the offices of the governing bodies of UN-Habitat should ideally take place **2025**, pending further consideration of this recommendation today by our Bureau.

- The recommendation from the Bureau of the CPR was forwarded to all of us on 20 April 2023.
- I now invite the Executive Director to provide a summary of the recommendation emanating from the Bureau of the CPR at its meeting held on 20 April 2022 for aligning the Quadrennial Comprehensive Policy Review process (QCPR) with UN-Habitat strategic planning cycles and the elections of the governing bodies of UN-Habitat.

#### **DECISION**

May I take it that the Bureau wishes to endorse the recommendation of the Bureau of the CPR at its meeting held on 20 April 2023, namely that:

- a) The alignment of UN-Habitat planning cycles with the QCPR should take place in **2025**;
- b) The current 2020-2023 Strategic Plan of UN-Habitat be extended to cover the period until 2025, as already recommended by the Executive Board in paragraph 14 of its Decision 2021/6
- c) The regular second session of the United Nations Habitat Assembly to be held from 5 to 9 June 2023 be adjourned, and resume in 2025 for the purpose of approving a new Strategic Plan to be prepared by the Executive Board for the period 2026-2029, which will align with the QCPR.
- d) The third regular session of the United Nations Habitat Assembly should be held in 2029 that will ensure full alignment of UN-Habitat planning cycle with the QCPR

It being understood that the **implication of the above scenario with respect** to the elections of the governing bodies will be further discussed by Member States during the informal consultations of the CPR which will take place in the upcoming weeks starting from tomorrow Tuesday 25 April 2023, and that we shall discuss this matter again at our next Bureau meeting.
