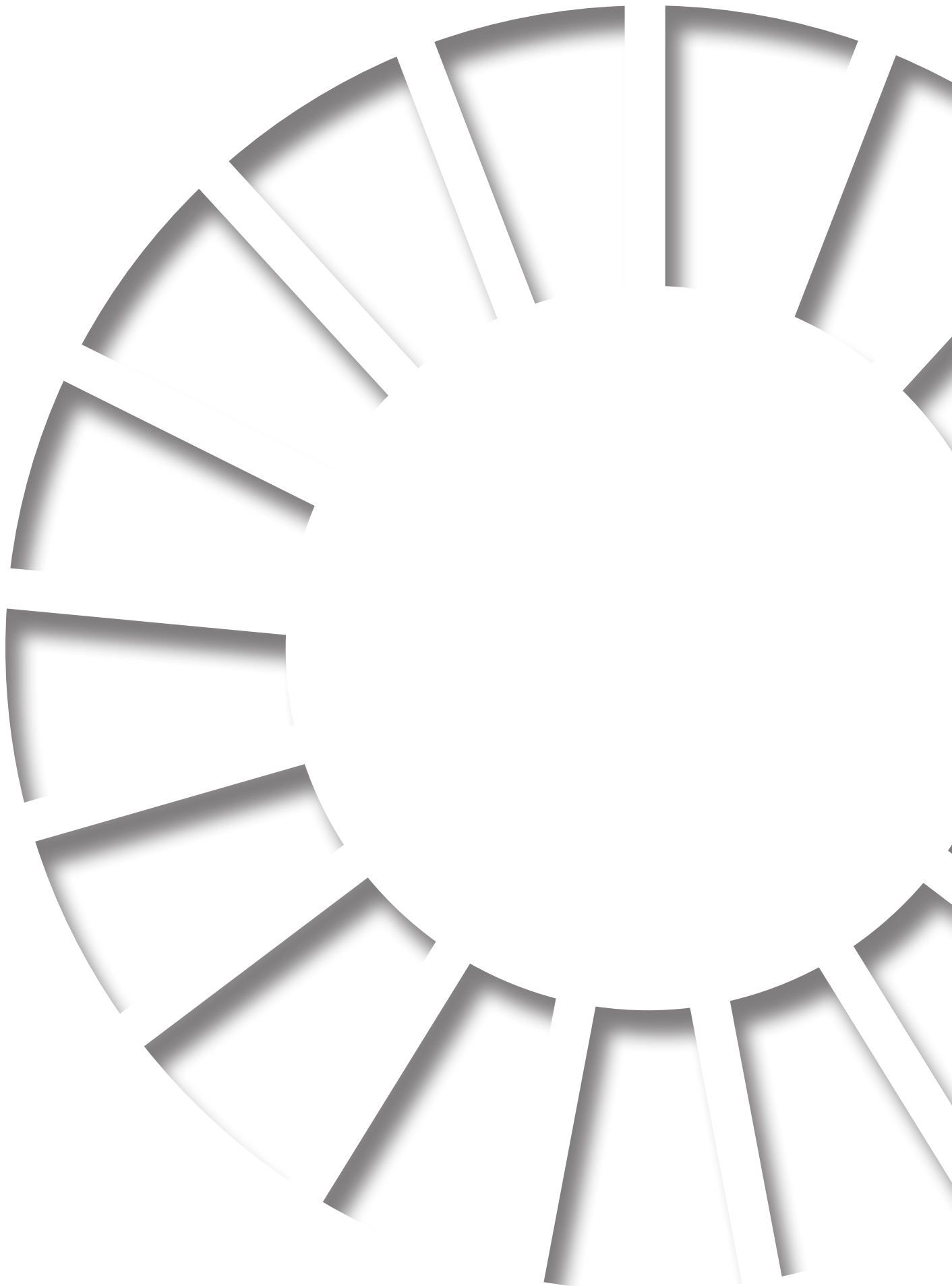

Introduction

On 10 April 2018, the Basque Government approved the first Euskadi Basque Country 2030 Agenda, linking the goals and targets of the 2030 Agenda to the commitments of the Government Programme.

Giving continuity to the work developed since 2018, on 29 June 2021, the Basque Government approved the Basque Programme of Priorities for the 2030 Agenda, in which it constitutes, for the period 2021-24, the action plan for the Legislature of the General Secretariat for Social Transition and the 2030 Agenda of the Presidency of the Basque Government.

This plan is articulated in direct connection with the Government Programme for the XII Basque Legislature. The established indicator system informs on the fulfilment and contribution of said Legislature and of its sectoral and ministerial policies, in relation with the 17 Sustainable Development Goals and their 169 targets. It therefore enables the making of an assessment and the drawing of conclusions projected into the immediate future.

The mission of the Basque Programme of Priorities for the 2030 Agenda is to promote a culture of social contract linked to the transformative focus of the Sustainable Development Goals and to the call to the Decade of Action.

It establishes four priority axes: dissemination, coordination, evaluation and prioritisation. Its fundamental objectives are: to contribute to internal social cohesion; to be part of the best international efforts for peace, justice and sustainability; to promote policy coherence; and to take ownership of the 2030 Agenda as a commitment to promote transformative priorities.

This programme for the legislature establishes a dashboard of seven tractor commitments and seven emblematic projects in the areas of equity, education, climate, energy and biodiversity, urban agenda, global health, circular economy and the prevention of violence and the protection of peace.

From the point of view of Governance and of interinstitutional and social collaboration, the Multi-Stakeholder Forum for Social Transition and the 2030 Agenda has been created. An initiative uniting the different Basque Government Ministries, the three Provincial Councils, EUEDEL (Basque Municipalities association), the Councils of the capital cities and the Basque universities, in addition to representative bodies of public-private collaboration and of organised civil society.

This is the fifth Voluntary Monitoring Report. It documents the deployment of this commitment throughout 2021. It summarises the more than 2,000 significant actions associated to each SDG and its respective targets, developed by the Basque Government through its different Ministries. These actions are published and available on Irekia, the open government website.

Sustainable Human Development is, for the Basque Government and all of the Basque public institutions, the guiding principle of their public policies. After two years of pandemic, the global challenge of the United Nations takes on even greater significance. The 2030 Agenda is a necessity and an opportunity for the world and for people. It is a Basque Country commitment.

Summary of main milestones in 2021

People

People have been the essential focus of Basque Government management in a situation still affected by the pandemic. All urgent, necessary and important actions have focused on responding to the pandemic. A response not only in terms of healthcare, but also of an economic, a social and an emotional nature, aimed at promoting and sharing prosperity.

The Basque Institutions have amassed a combined budget of 12.442 billion euros for 2021, an extraordinary economic effort to tackle the consequences of COVID-19. This effort has been estimated at 5.100 billion euros in additional resources, 2.2 billion euros of which have been for direct grants to help the people and sectors affected and 2.9 billion for tax deferrals and loans and the underwriting of fixed-income securities.

From an ethical perspective and a commitment to human dignity, the attention to people has been a priority together with healthcare, as has the support of other policies, especially in the social policies and educational field.

- In terms of **social policies**, a further 179 million euros have been assigned to grants for the people in greatest need and those directly affected by the health crisis. Allowances towards the rental of a habitual residence, top-up allowances towards work-life balance, reinforced care services for the dependent and special support programmes including "Inor Atzean Utzi Gabe" (leave no-one behind), in collaboration with the third sector, are some of the reinforced measures in place to deal with the additional needs created by the pandemic.

- In the field of **education**, an extraordinary effort has been made in 2021 to guarantee the maintenance of in-person education. Teaching staff numbers were increased with an additional 1,064 places and the commitment to digitalising Basque schools resulted in an Integrated Digitalisation Plan under which an investment of 1 billion euros is envisaged over the next three years. This Plan will, among other measures, provide students with the use of a laptop computer from year five of primary school in the endeavour to bridge the digital divide.

- With regard to **Vocational Education and Training** a new Plan will meet the fresh challenges facing Basque Vocational Education and Training in the process of economic transformation

underway in the Basque entrepreneurial network. The basic pillars of this new Plan are providing jobs to women in industry, digital and energy transition, dual and alternating education, and incentives for new companies connected to Vocational Education and Training.

- With respect to care for **the elderly**, a programme providing care to 62.000 people has been reinforced. Experience has shown that we must work together on an updated model of caring for the elderly and in 2021 a Strategic Social Services Plan was therefore drawn up to promote the transition towards a new model of care. A new model enabling the elderly to maintain an independent life in their own homes and family environment for as long as possible. A new and more human and friendly model of homes to achieve greater integration of the health and social fields.

- In relation to **equality**, special attention was dedicated to addressing male violence during the pandemic. Resources and services for victims were consolidated, as was the 24/7 telephone helpline. Also presented was the project of a social and public pact against male violence, an initiative framed within the international project "Generation equality" by UN Women. All of these reinforced steps and measures will receive a boost with the Law on equality and against male violence, which has been approved in the Basque Parliament in March 2022.

- Concerning **young people**, intensive work has been done on the draft of the youth law, which was also adopted in March 2022. The main objective is to advance the age of youth emancipation, through the Basque Youth Strategy 2030 and instruments such as the Basque Youth Emancipation Network, among others.

The Strategy will focus on those factors, objective and subjective, that most contribute to reducing the age of youth emancipation: quality employ

ment and access to youth housing, information, guidance and personalized support in transit itineraries to adult life and the culture (values and expectations) of young people and their families regarding emancipation and its conditions.

In this sense, in 2021, the improvement and budget reinforcement of programs that subsidize up to 275 euros for the rental of a home for young people, together with other actions focused on youth included in the Housing Master Plan and in the Strategic Employment Plan. And a first call for aid to Town Halls for the systematization and evaluation of actions for emancipation has been launched.

•In the field of the **Basque Urban Agenda Bultzatu 2050** the frameworks are in place for coordinated action between the relevant agents in the Basque Country with a view to intensifying the objectives of establishing a sustainable, dynamic and socially united urban territory.

In particular, the portfolio of projects driving the Urban agenda has been defined, composed, among others, by the emblematic Opengela project, the Bepiztu initiative and, more specifically, the Special Plan for the Relaunch of Disadvantaged Districts or Preferential Areas of Action (ZAPS) and the projects linked to Euskadi Next.

•Also within the framework of urban planning and in the **housing** field is remarkable the approval of a "Housing Master Plan 2021-2023", with an investment of 1.237 billion euros. The Plan envisages the building of 4,000 new subsidised housing units: 2,250 through a state-owned company and the remainder by private developers. Furthermore, another 3,000 rent-controlled housing units will be added to the housing stock.

•Regarding the **demographic challenge**, considered as one of the national objectives, the 2030 Basque Demographic Challenge Strategy has been approved and submitted to economic and social stakeholders for their consideration and participation. This strategy consists of 25 initiatives, amongst which are one grant per child. This reconfigures, unifies and increases the incentives received by families with a view to progression; a programme of loans which are either interest-free or have the option of long-term repayment for entrepreneurial, training, or housing projects

for young people, in addition to measures fostering access to housing for young people, youth employment, shared work-life balance and taking up life in the countryside.

•In the field of **culture**, a digital library was launched in 2021 with 750,000 entries belonging to the collections from 34 Basque libraries. This library will be connected to its European counterpart, the European digital library, and to the Digital Public Library of America.

Further to the above, a fresh boost has been given to the cultural and creative industries by means of a cluster group in collaboration with the Ministry of Education and presentation of the Basque District of Culture and Creativity (BDCC).

•Lastly, in the field of **human rights and memory** we must mention approval of the Law on Historical and Democratic Memory. Likewise, the Udaberri 2024 strategy, an integrated strategy in favour of human rights, was also approved on 21 September.

•With respect to the **emblematic projects** framed within the People pillar, the Ekitatea project, focussed on reducing inequalities and preventing exclusion, has already presented its advances in the Work Group of the Multi-Stakeholder Forum for Social Transition.

The "Hezkuntzaren Auzolana project-Education for all" has defined and presented its priority pillars in a publication, together with the anticipated goals and actions, all associated to monitoring indicators.

With respect to the Opengela Project, in the framework of the Basque Urban Agenda-Bultzatu 2050, implementation has continued in 2021, rolling out its model in different districts, and strengthening urban regeneration actions in deprived neighbourhoods throughout the Basque Country.

Regarding the emblematic project in the field of peace and human rights, going by the name of "Knowledge learned from the Basque Case for the prevention of violence and protection of peace", the first advances have been made in preparation for its presentation in early 2023.

Prosperity

Together with the commitment to people and preferential attention to social policies, in 2021 the Government laid the foundations for economic recovery and employment.

The ongoing situation of economic uncertainties at world level remains a fact. Restrictions on international trade, disparities between the supply and demand of basic materials for vehicles for example, energy prices, the new economic and commercial limitations potentially arising from the appearance of new COVID variants or uncertainty regarding the evolution of interest rates and inflation, are burdens that are slowing the recovery of emblematic industries and sectors across the globe, such as the automotive industry. This said, the Basque Country has proven its ability to overcome the most critical moments and adapt to this new reality. Proof of this are the forecasted GDP growth of 5.6% in 2021, the recovery of industry, the reduction in unemployment numbers by 14,395 Social Security payers, whose numbers stood at 980,002 in December 2021, very close to the historic record of 982,935 contributors existing in July 2008.

The bases of economic recovery and social policies for the coming year have been shored up thanks to approval of the 2022 budget, the highest ever in the history of the Basque Country.

Among the foundations for economic recovery of the Basque Country are the following:

- The **Berpiztu Plan**, launched at the beginning of the legislature, is proving to be of fundamental importance for Economic Recovery and Employment. The different policies developed have provided an incentive for 53,500 jobs in the period 2020-2021. The forecast for 2022 is that the new investment will stand at some €3.21bn and that the number of jobs created will reach almost 35,000 people.

- Furthermore, at the Berpiztu Board Meeting, held in March, the decision was made to approve €180m in extraordinary funds for the purpose of revitalising **Areas of Preferential Action** (or Disadvantaged Areas). These extraordinary funds are already being put to use by the local departments and organisations concerned through 25 specific action projects in the districts of Enkarterri, Ezkerraldea, Meatzaldea and Oarsoaldea. Work is currently underway to identify specific strategic projects in the district of Aiaraldea.

- Together with the Berpiztu Programme, which reflects the Government's endogenous budgetary

efforts, expectations are placed on the European funds of the **Euskadi Next Programme**. The government approved updating of the Euskadi Next Programme, under which investments of some €18bn are envisaged. In 2021, the Basque Country received €692m from the Spanish Government, entrusting it with managing the development of different programmes through the different Government ministries.

- In addition to investment, the economic recovery of the Basque Country is bolstered by the determined commitment to innovation. We have approved the new **Science, Technology and Innovation Plan** until 2030, with estimated public-private investment of almost €20bn. Our public commitment is reflected in the rising budgets assigned to R&D within the Government. In 2021 this growth stood at almost 10%, and commitment to the rest of the legislature is to increase it by 12%. We will therefore double the 6% annual public investment in R&D to which we are committed in our Government Programme. Thanks to these efforts, the Basque Country has been qualified by the European Union as a most innovative region and as an excellence hub.

- Innovation is the driving force behind a solid and competitive industrial base. The Government has established as a Country Goal the aim that industry and advanced services will reach 40% of our GDP. To succeed, together with the STIP 2030, we have approved the **Strategic Industrial Development and Business Internationalisation Plan**. The Euskadi 2025 digital transformation strategy has been approved. The Basque Cybersecurity Centre has been consolidated. We have launched an integrated plan of support for small and medium-sized enterprises amounting to €430m. Approval has also been given to the Inter-institutional Entrepreneurial Plan with a budget of €250m and the Basque Artificial Intelligence Centre (BAIC Association) has been launched, in which the Government has participated with some twenty technology stakeholders and companies connected to artificial intelligence.

- Regarding support to **shops, hospitality and tourism** in dealing with the negative effects of COVID-19, in the period 2020-2021 the Government has invested a total of 114 million extraordinary resources in supporting the sector, both in the shape of direct subsidies and by providing

incentive to buy through the different subsidised vouchers for spending on hospitality, tourism and in shops. The Next Generation EU funded “Basque Sustainable Tourism Strategy” has also been approved. The Basque Country will receive, until 2023, a total of €67m under the agreement reached with the Spanish Government to fund this international plan.

•In the field of **work and employment**, the Basque Employment Strategy 2030 has been approved, which aims to open a new period in employment policies focussed on quality, inclusion and equality and addresses recognition of the subjective right to training and work, with the vocation of ensuring that employment serve to achieve progress and social cohesion of the Basque Country. It should be underlined the Social Dialogue Panel which consolidates its role to negotiate public policies in favour of quality employment, with the signing of the agreements reached by the different work groups. Similarly worthy of note, in the same way, the Basque social pact for fair transition to industry 4.0. This pact is centred on the three essential questions

that must accompany this process: a framework of professional qualifications and specialisations, the programme for training in new employment niches, and a plan of priorities for advancing in achieving the indispensable equality between women and men.

•Regarding the **emblematic projects** corresponding to the Prosperity pillar of the Basque Programme of Priorities, the Basque Health Service and the Basque Agency for Development Cooperation have already defined a first action plan under the Global Health Project focussed on sharing knowledge learned and conveying public health skills to the Malawi health services.

The Basque Ecodesign Center project is promoting more sustainable ways of thinking in the Basque industrial sector in line with the European Green Deal and the Basque Green Deal. This initiative generates knowledge by means of innovation in priority areas, while also drawing the Basque industry value chain towards a more circular economy.

The planet

The Basque Government's commitment to the Planet constitutes a strategic area. Environmental Sustainability, the Circular Economy and Energy Transition are the elements on which we are providing a response to our commitment to the planet from the Basque Country.

The Basque Green Deal Initiative, in line with the European Green Deal, was presented in May. This initiative is not only a commitment to the climate or an environmental policy, but also a model with the industry as an economic driving force and with technology as the main lever of transformation.

- Public policies focused on the productive economy, such as technology, innovation, entrepreneurship, digital transformation, industrial development, energy, the circular economy and bioeconomy, agriculture, fishing and the food industry, are reinforced according to the criteria defined in the Basque Green Deal, with the aim of promoting a new model of sustainable and inclusive development. As far as **planning and legislation** connected to this Basque Green Deal is concerned, 2021 has been particularly remarkable. Approval has been given to the Circular Economy and Bioeconomy Plan 2024, the Gastronomy and Food Plan 2024 (including the strategy against food waste), the Energy Transition and Climate Change Plan 2024, and the Waste Prevention and Management Plan 2030, which envisages investments of almost 100 million euros to promote waste recycling, reduction and reuse. In turn, approval has been given to laws on Environmental Administration and Conservation of the Natural Heritage of the Basque Country.

- Outstanding in the field of **the circular economy** is the opening in March of the Basque Circular Hub, Southern Europe's only centre for advanced studies, where 130 young people have received training and practical experience in circular economy. In this same line, in June the agreement was signed to launch the third period of the Basque Ecodesign Center, running until 2025. In total, 14 major Basque companies have joined this new agreement, together with Ihobe, Spri and the Basque Government itself. Finally, we must highlight the launch of a new line of grants going by the name of Pyme Circular, intended to promote the application of circular economy methods and actions in small and medium-sized Basque enterprises, maximising the skills and knowledge of the different stakeholders in our environment.

- As regards **energy transition**, the Energy Intelligence Center has been set in motion, promoting renewable energies jointly with public-private collaboration. Fine examples of this commitment are

projects such as Ekian on the generation of photovoltaic energy; Ekiola for the promotion of cooperative energy communities; and EuropeWave, for the development of wave energy. Also worthy of note is launch of the Basque Hydrogen Corridor macro-project, the result of public-private collaboration and which has the participation of more than 120 organisations including companies, technology centres and local bodies, some of them members of the European Clean Hydrogen Alliance.

- In the field of **climate action**, the Basque Country has assumed the commitments of the COP26 world climate change conference held in Glasgow. The Basque Country is committed to reducing greenhouse gases by 45% and to achieving zero net emissions by 2050. Basque industry has already taken the first step. In October, the Basque industry pledged to achieve zero net emissions on joining the world alliance currently being developed by the World Economic Forum with a view to promoting transition of the Basque clusters to net zero emissions. Creation of the Basque Net Zero Industrial Super Cluster has the objective to accelerate the journey towards zero net emissions in the Basque Country, fostering decarbonisation of the energy supply and energy efficiency in the industrial sectors and creating market opportunities based on the extension of innovative new technologies and services.

- Connecting both transitions, the **Basque Energy Transition and Climate Change Bill** was drawn up in 2021. Given the crucial nature of this Bill, the Basque Government Ministry of Economic Development, Sustainability and the Environment has promoted an ambitious process of public participation and in which social agents have been key with regard to the co-creation and agreement on the objectives to be achieved. The executive is expected to submit the Bill to the Basque Parliament in the second semester of 2022.

The **emblematic projects** of the Planet-Ecology pillar of the Priorities Programme made progress in 2021. On the one hand, the Ekiola project has contributed to the constitution of energy communities in different municipalities where the residents themselves participate in the generation and management of solar energy for their own use. On the other hand, the Clima-Ondarea project has taken its first steps towards the broader sustainable use of natural resources and the improvement of its ecosystem services.

Alliances

When fostering the SDGs, promoting solid, inclusive and integrated alliances and partnerships at all levels is a priority area for the Basque Government. The aims are to broaden commitments and shared projects, identify best practices, promote new collaborative experiences, and to extend and disseminate the commitment to involvement in and application of the Sustainable Development Goals.

•In the field of alliances, on 6 July 2021 the Basque Government approved the Decree creating the **Multi-Stakeholder Forum for Social Transition and the 2030 Agenda in the Basque Country**. This body will promote shared Governance of the 2030 Agenda between all Basque institutions and social stakeholders. It will have a Plenary Body, a Permanent Commission and five Work Groups: Governance, the Basque Urban Agenda – Bultzatu 2050, Social Transformation, Energy-Climate Transformation and Economic-Digital Transformation.

This Forum is chaired by the Basque President, Lehendakari Iñigo Urkullu Renteria, and its members are all Basque Government Ministers, the three Provincial Councils, EUDEL (the Association of Basque Municipalities) and the capital city Councils, the rectors of the three Basque universities, a representation of third sector organisations in the Basque Country through Sareen Sarea, and representatives of public-private collaboration through the Basque Center for Climate Change (BC3); the Basque Research and Technology Alliance (BRTA); and ACLIMA, the Basque Environment Cluster.

On 9 November 2021 the Multi-Stakeholder Forum for Social Transition and the 2030 Agenda was constituted. The document “Structure, priorities and first work agenda” was approved at its first meeting. Its structure was distributed into Work Groups and its Management Plan for 2022 was drawn up before the end of 2021.

•In addition, the **Guneak Initiative** has been relaunched on collaboration between myriad stakeholders which, based on the pilot experience developed during the last legislature, will now be addressed in the Work Groups on Social Transformation, Energy-Climate Transformation and Economic-Digital Transformation.

•One example of the partnership strategy is the **Basque Government’s Framework Agreement with EUDEL** (the Association of Basque Municipalities). The coordinated implementation of the 2030 Agenda at local level in the Basque Country is framed within the participation of EUDEL as a representative of the BAC municipalities in the Multi-stakeholder Platform. The 15 strategic projects selected, in line with the tractor commit-

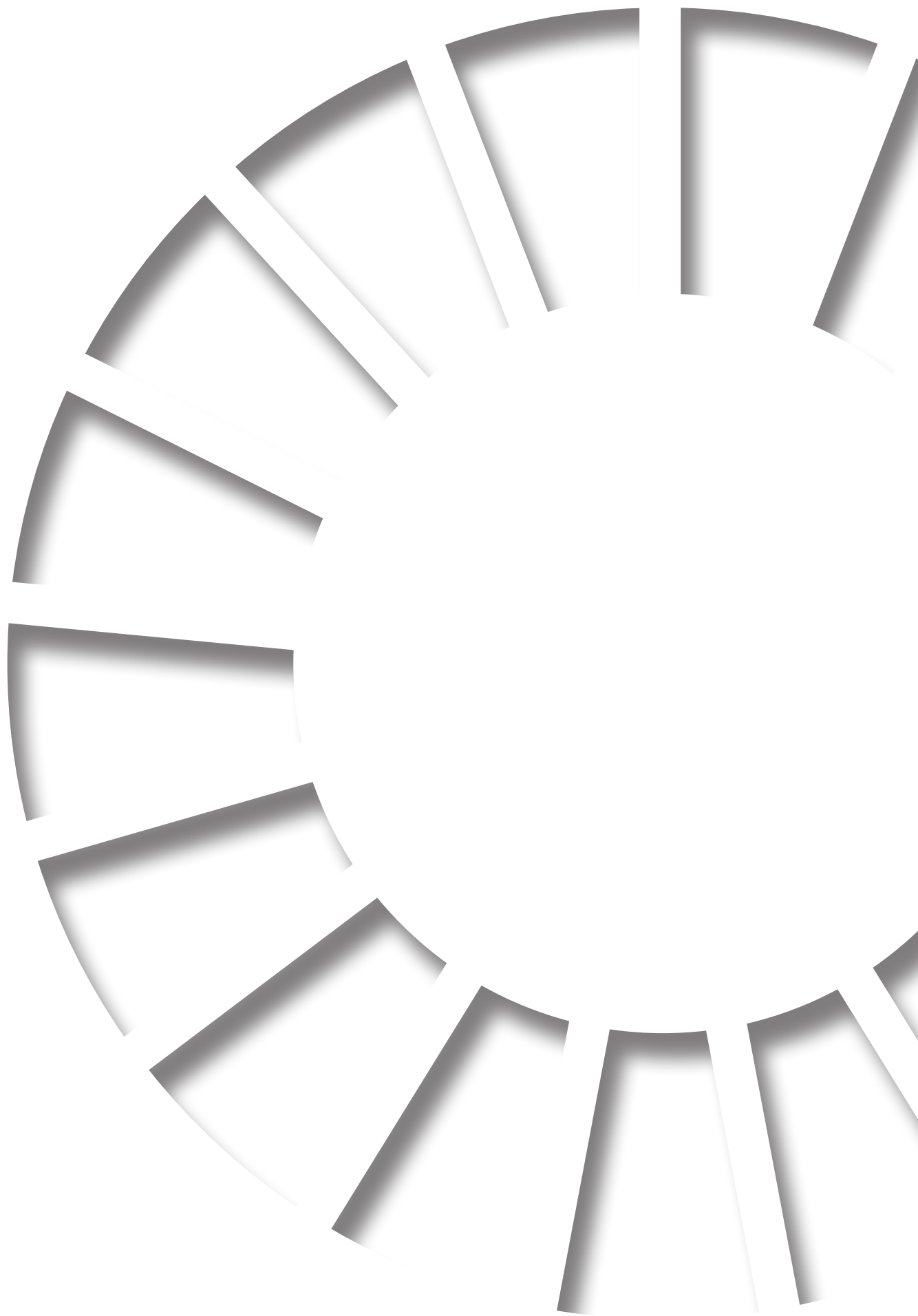
ments of the Basque Programme of Priorities, encompass the four aspects of sustainability: social development, economic development, environment and governance.

Worthy of note are projects such as the local model of shared care-providing with a feminist focus; the counting and diagnosis of people with severe housing problems; Zaindu/InguruarEKIN, the fostering of social entrepreneurship; local governance focused on the 2030 Agenda and the SDGs: the evaluation of sustainability and local action policies, and the Covenant of Mayors for Climate and Energy.

•Also worthy of note is the **permanent collaboration with EGK** (Euskadiko Gazteriaren Kontseilua-Basque Youth Council) aiming to involve young people in the task of raising awareness, disseminating and implementing the 2030 Agenda and the collaboration agreement signed with **Jakiunde**, the Academy of Sciences, Arts and Letters. An agreement which has the objective of generating knowledge applied to the field of social transitions in general and to the demographic challenge in particular, hence making it possible to guide the action and priorities of the Basque institutions in coming years.

•Lastly, we must highlight that the three lines of work undertaken within the Governance Work Group, i.e. Inter-institutional Coordination, Monitoring and Assessment of the 2030 Agenda and International Action, faithfully reflect a policy of alliances and partnerships integrated at all levels.

•Note should also be made of the creation of workbooks on the Basque Demographic Challenge Strategy 2030; the configuration of a single indicator dashboard for monitoring and assessing the 2030 Agenda, drawn up together with Eustat, and participation in the ECOSOC Partnership Forum, representing, as well as the Basque Government, Regions4 and the UN Local Authorities Major Group. Added to these is participation in the European Commission’s Joint Research Centre study “Towards green transition, the role of Smart Specialisation prioritisation to support transformative innovation”, where the sustainability challenges and the Sustainable Development Goals will be developed by means of smart specialisation.

- IV Basque Social Inclusion Plan 2017-2021**, to provide a response to the new challenges and promote anticyclical measures making it possible to address the impact of periods of economic crisis, with special attention to adopting the gender focus in the field of inclusion.
