The second open-ended meeting of the Committee of Permanent Representatives to UN-Habitat in preparation for the second session of the United Nations Habitat Assembly will be held from 29 to 31 May and on 2 June 2023 in a **hybrid** format at the UN-Habitat headquarters in Nairobi, Kenya, combining in person participation in Conference Room 2 at the United Nations Office at Nairobi (UNON) complex and online participation¹.

The recommendation of the dates of the meeting takes into consideration the fact that 1 June 2023 coincides with "Madaraka Day", a national holiday in the Republic of Kenya, the Host Country for the meeting. In light of this, the meeting will be suspended on 1 June and resume on 2 June 2023.
