# Multilateral Governance through Korea National Urban Policy Programme in 8 Countries: Transforming Life from Phase1 to Phase 2

#### **SUMMARY**

This side event aims to share knowledge and experiences of how multilateral governance can be implemented through the National Urban Policy Programme (NUPP) within National Urban Policy (NUP), Smart City Strategies (SCS) and demonstration projects. The event will include presentations and discussions about National Urban Policy Programme (NUPP) funded by the Ministry of Land, Infrastructure and Transport (MOLIT) of the Republic of Korea.

Policy, Legislation and Governance Section (PLGS) of UN-Habitat has been working on NUPP since 2014. This event will present the experiences focusing on multilateral governance including Korea NUPP Phase 1 (2017-2021) success stories from 3 countries (I.R. Iran, Myanmar, and Niger State (Nigeria)), expected challenges, and proposed solutions to implement Phase 2 (2022-2026) in the 5 countries (Azerbaijan, Cambodia, Egypt, Mozambique, and Paraguay).

This session will also cover Korea's urban policies and smart city strategies presented by the MOLIT. This will allow further discussions on urban policies in Korea and eight participating countries as well as give feedback to each other. Participants are expected to benefit directly from Korea's NUP process as countries will exchange knowledge gained from and with each other. The event will emphasize on the need for advanced collaboration between stakeholders of NUP to address sustainable urbanization. The discussion session will also allow invited speakers, panelists and audience to ask questions, share practical lessons and ways forward.
