Item 1

Opening of the session

- 1. The Executive Board of the United Nations Human Settlements Programme (UN-Habitat) held its second session of 2023 in a hybrid format on Thursday, 8 June 2023 on the margins of the second session of the United Nations Habitat Assembly (UN-Habitat Assembly). The report of the Executive Board on its work at that session is set out in document HSP/EB.2023/6, while the decisions adopted by the Board at that session are set out in document HSP/EB.2023/7.
- 2. During the second session of 2023, the Executive Board agreed to entrust the Bureau of the Executive Board with the preparation of the provisional agenda and determining the appropriate dates and duration for the third session of 2023 of the Executive Board, taking into consideration the outcomes of the second session of the UN-Habitat Assembly. The provisional agenda, as proposed by the Bureau, is set out in document HSP/EB.2023/10.
- 3. Under item 1 of the provisional agenda, the Chair will declare the third session of 2023 of the Executive Board open and outline the procedures for the session.

Action: Opening of the session by the Chair of the Executive Board.

Item 3

- 9. In line with the decisions of the Executive Board, in particular with paragraph 7 of decision 2019/2, in which the Board decided to establish an ad hoc working group on programmatic, budgetary and administrative matters, and paragraph 5 of decision 2019/3, in which it decided to establish an ad hoc working group on the development of a draft stakeholder engagement policy, the chairs of the two ad hoc working groups will report on the work of those groups.
- 10. In line with decision 2/4 adopted by the UN-Habitat Assembly at its second session, in which it requested the Executive Board, on an exceptional basis, to continue its work to develop a stakeholder engagement policy and to submit the draft policy for consideration and possible approval by the Assembly at its resumed regular second session, the Chair of the ad hoc working group on the development of a draft stakeholder engagement policy will update the Board on the progress made in the development of the draft stakeholder engagement policy.

In paragraph 1 of decision 2/1, the UN-Habitat Assembly decided to extend the strategic plan for the period 2020–2023 until 2025 to cover the period 2020–2025, in order to align the planning cycle of UN-Habitat with the quadrennial comprehensive policy review of operational activities for the development of the United Nations system. In that regard, the secretariat will provide an update on the implementation of the resource mobilization strategy in accordance with the strategic plan for the period 2020–2025.
- 13. In line with paragraph 2 of decision 2023/1 of the Executive Board, the secretariat will also deliver a presentation on the fully costed scalability model, including advice from the Advisory Committee on Administrative and Budgetary Questions. In addition, the secretariat will provide information on actions by UN-Habitat to address geographical and gender imbalances in the composition of its staff.
- 14. The Executive Director will provide a briefing to the Executive Board in preparation for the discussion on the financial, budgetary and administrative matters of UN-Habitat.

Draft terms of reference of the urban action funding window to support the implementation of United Nations Habitat Assembly resolutions in a balanced manner

- 21. In paragraph 3 of resolution 2/10, the UN-Habitat Assembly decided to establish an urban action funding window within the United Nations Habitat and Human Settlements Foundation to attract and manage funds from donors to fund the implementation of resolutions adopted by the UN-Habitat Assembly that lacked adequate financing. In paragraph 4 of the same resolution, the UN-Habitat Assembly requested the Executive Director, in consultation with the Executive Board, to develop the terms of reference of the urban action funding window, noting the need to achieve the implementation of UN-Habitat Assembly resolutions in a balanced manner.
- 22. Accordingly, under this item, the Executive Director will first provide an overview of progress in the implementation of resolutions adopted by the UN-Habitat Assembly and then a briefing on the proposed draft terms of reference of the urban action funding window to support the implementation of UN-Habitat Assembly resolutions in a balanced manner.

Action: Briefing by the Executive Director progress in the implementation of resolutions adopted by the UN-Habitat Assembly and on the proposed draft terms of reference of the urban action funding window followed by discussion. The Executive Board may wish to take note of the briefing by the Executive Director and provide further recommendations.

- 24. Accordingly, under this item, the Executive Director will provide a briefing on the road map for preparations for the development of international guidelines on people-centred smart cities.

Action: Briefing by the Executive Director on item. The Executive Board may wish to take note of the briefing by the Executive Director and provide further recommendations.
