# Information Note for Participants

Third session of the UN-Habitat Executive Board in the year 2023

### Introduction

The second session of the Executive Board for the year 2023 was held on 8 June 2023. The draft report of the Executive Board on the work of that second session in 2023 is set out in document HSP/EB.2023/9 and can be accessed here.

At that second session of 2023, the Executive Board agreed to entrust its Bureau with determining the appropriate dates, number of days within the quarter of 2023, for the third session of the Executive Board. The Board also agreed to entrust its Bureau with the preparation of the provisional agenda for the 2023 third session of the Executive Board, taking into consideration any outcomes from the second session of the UN-Habitat Assembly. Subsequently, the Bureau on 1 September 2023 recommended that the duration for the third session of the Executive Board for the year 2023should be three days and that the dates for that session should be 28 to 30 November 2023.

Accordingly, the third session of the Executive Board for the year 2023 is scheduled to take place from Tuesday, 28 November to Thursday, 30 November 2023. The provisional agenda, which was considered and prepared by the Bureau can be found here.

### Modalities of Participation (Fully in-person)

The 2023 third session of the Executive Board will be held fully in-person at the UN-Habitat Headquarters in Nairobi, which is located at the United Nations Office in Nairobi (UNON), as recommended by the Bureau, considering that COVID 19 is no longer a global pandemic and in light of the lifting of the COVID restrictions at the Conference Room 2 at UNON will be used for the three-day session.

### **Travel Requirements**

### COVID-19 protocols

The COVID-19 pandemic has recently abated in most regions of the world. The positive trend has also been noted in Kenya with low reported infection rates. Notwithstanding this, the World Health Organization still recommends that caution is applied where risk for COVID-193 infection is high, e.g., in crowded, poorly ventilated spaces or when one's personal risk of adverse outcomes from COVID-19 is high. Some of the key preventive measures advised include keeping up to date with COVID-19 vaccination, practicing hand hygiene, and using masks when risk of infection is deemed to be high.

All participants arriving into the country are no longer required to show proof of either COVID-19 vaccination or a pre-departure COVID-19 test. However, participants arriving with flu-like symptoms will be required to fill a passenger locator form and to take a COVID-19 antigen test at their own cost. Those who test positive will be required to take a further COVID-19 PCR test at their own cost. Those with severe symptoms shall thereafter be required to isolate as per the prevailing isolation requirements.

#### **Travel to Kenya**

- c. You will be informed of your accreditation status before or onwards from 24 November 2023 or will be contacted earlier if more information is required.
- d. Please note that it is essential that we receive the requested documentation by 24 November 2023 at 14:00 East Africa Time (EAT) the details indicated above to be able to proceed with your registration.





### Opening and closing of online registration

All delegates, as well as entities and non-governmental organisations participating as observers are encouraged to register online https://unhabitat.org/meetings/third-session-of-2023-of-the-executive-board from Tuesday, 17 October 2023.

It is important that the Secretariat receives complete contact details, including exact title and designation.

Please note that online registration is mandatory and will close on Friday, 24 November 2023 at 14:00 East Africa Time (EAT).

Although delegates based in Nairobi who already have a ground pass issued by UNON can use this pass during the 2023 third session of the Executive Board, it is strongly advised that they also register online and be issued with badges to allow easy access to specific areas.

### **On-site registration**

After online registration, delegates and entities participating as observers, **not holding a UNON ground pass**, as well as non-governmental organization and media representatives, are welcome to collect their badge at UNON, Pass & ID office (entrance via Visitors Pavilion) on:

- Monday, 27 November 2023 from 09:00 to 16:00, East Africa Time (EAT) and
- Tuesday, 28 November 2023 from 08:00 to 16:00, East Africa Time (EAT).
