 - i. Developing cutting-edge practical tools and guidance to strengthen the connection between NUA reporting, Voluntary National Reviews and Voluntary Local Reviews;
 - ii. Providing tailored capacity building on NUA and SDG data and reporting through the use of the [Global Urban Monitoring Framework] {NLD+} and scaling up the use of VLRs;
 - iii. Enhancing multilevel governance and coordination for the NUA and achievement of the SDGs; and
 - iv. Facilitating multistakeholder partnerships and the mobilization of adequate financing to accelerate SDG achievement and NUA implementation at the local level.] {MAR+}
