Statement by the Ambassador of Colombia on Subprogramme 1: Reduced Spatial Inequality and Poverty in Communities Across the Urban-Rural Continuum

We want to thank the secretariat for this presentation. Colombia supports the Draft Work Programme and the Draft Budget for 2024. We particularly welcome the Subprogramme 1, aimed at reducing spatial inequality and poverty in communities across the urban-rural continuum. This subprogramme aligns closely with Colombia's national goals and aspirations, and it is a testament to the United Nations' commitment to addressing pressing issues that resonate deeply with our country.

Statement by the Ambassador of Colombia in Kenya on Agenda Item 7: Principal Obstacles to the Implementation of the New Urban Agenda by Member States

Mr. Chair,

Ladies and Gentlemen,

Thank you very much to the secretariat for the presentation which addressed the principal obstacles to the implementation of the New Urban Agenda by Member States.

Since Habitat III Colombia has been diligently incorporating and aligning the principles and commitments of the New Urban Agenda into our national programs, plans, and actions. We recognize the transformative potential of this agenda in shaping the future of our cities and human settlements.

On March 31, 2021, Colombia proudly presented its first voluntary report on the progress made in implementing the New Urban Agenda. The report provided a valuable opportunity for Colombia to assess our achievements and challenges in promoting sustainable urbanization and inclusive urban development.

Colombia firmly acknowledges that the New Urban Agenda represents a common ideal. We believe in the power of urbanization to drive social and economic progress, foster innovation, and improve the quality of life for our citizens. We wish to praise the importance of mainstreaming the New Urban Agenda into national policies and planning processes.

However, we must also address certain challenges that hinder effective mainstreaming and implementation. In addition to the challenges posed by rapid urbanization, inequality, and environmental degradation, the dual burden of a high number of indicators and the persistent lack of funding poses significant hurdles for Member States. In this regard, we warmly welcome UN-Habitat's efforts in addressing these challenges and particularly refer to the commitment to focus on providing more accessible and locally contextualized normative tools and services for reporting. This approach aligns with Colombia's vision of tailoring urban solutions to our specific challenges and needs.

Additionally, the issue of language proficiency represents an obstacle, as many of the tools that support implementation, monitoring, and reporting require proficiency in English. This challenge is particularly pronounced in a country like Colombia, where a minority of the population is English-speaking.

Colombia believes that language should not be a barrier to the meaningful participation of all Member States in the implementation of the New Urban Agenda. We encourage the development of multilingual resources and the provision of technical assistance to bridge this gap.

Welcoming the Report of the Executive Director on Preparations for the Development of the Strategic Plan for the Period 2026–2029

In particular, Colombia emphasizes its keen interest in the resolution on biodiverse and resilient cities, which aims to mainstream biodiversity and ecosystem services into urban and territorial planning. We believe that this resolution holds great significance for our country, given our rich biodiversity and the need to ensure sustainable development that respects and protects our natural environment.

Colombia is actively engaged in ongoing consultations with the president of CAF (Development Bank of Latin America) to collaborate on a CAF-funded project. We emphasize the importance of unifying efforts and building upon existing projects undertaken by various regional development banks. Specifically, this project acts as a forerunner to pilot initiatives focused on biodiverse and resilient cities, potentially playing a key role in advancing the objectives of the aforementioned resolution. We encourage other regional development banks to join member states in supporting the implementation of such resolutions.

Colombia stands ready to contribute constructively to the development of the Strategic Plan for the period 2026–2029. We look forward to engaging in meaningful discussions and consultations throughout this process to ensure that the plan effectively addresses the challenges and opportunities facing urban development in the coming years.
