### Draft report of the Executive Board of the United Nations Human Settlements Programme on the work of its third session of 2023

Rapporteur: Mr. Arnaud Suquet (France)

### Introduction

- 1. The Executive Board of the United Nations Human Settlements Programme (UN-Habitat) was established in accordance with General Assembly resolution 73/239 of 20 December 2018, on the implementation of the outcomes of the United Nations Conferences on Human Settlements and on Housing and Sustainable Urban Development and strengthening of UN-Habitat.
- 2. The Executive Board held its second session of 2023 on 8 June 2023 on the margins of the second session of the United Nations Habitat Assembly of the United Nations Human Settlements Programme (UN-Habitat Assembly). At that session, the Executive Board had agreed to entrust the Bureau of the Executive Board with determining the appropriate dates and duration within the fourth quarter of 2023 for the third session of 2023 of the Executive Board. Subsequently, the Bureau decided that the third session of 2023 would be held in person from 28 to 30 November 2023.
- 3. Accordingly, the third session of 2023 was held at the headquarters of UN-Habitat in Nairobi from 28 to 30 November 2023.

### I. Opening of the session

- 4. The third session of 2023 of the Executive Board of UN-Habitat was opened at 9.15 a.m. on Tuesday, 28 November 2023, by the Chair, Silvio Albuquerque (Brazil), who outlined the arrangements for the session on the basis of the recommendations made by the Bureau of the Executive Board.
- 5. Opening statements were delivered by Zainab Hawa Bangura, Director-General of the United Nations Office at Nairobi; Maimunah Mohd Sharif, Executive Director of UN-Habitat; and Alice Wahome, Cabinet Secretary for Lands, Public Works, Housing and Urban Development, Kenya.
- 6. In view of her impending departure from her role as Executive Director of UN-Habitat, the Chair paid tribute to Ms. Mohd Sharif.
- 7. The representatives of the following States members of the Executive Board delivered statements, including tributes to the outgoing Executive Director: Argentina (speaking on behalf of the Latin American and Caribbean States), Angola, Barbados, Cameroon, China, Colombia, Egypt, France, Germany, Morocco, Nigeria, Portugal, Russian Federation and United States of America. Statements were also delivered by the representatives of Azerbaijan, Cuba, Malaysia, Philippines and Zimbabwe. The Executive Director responded to the comments made.

8. The Chair informed the Executive Board that Barbados had replaced Chile and that Colombia had replaced Costa Rica as members of the Executive Board representing the Latin American and Caribbean States.

The Executive Board agreed that informal consultations on the draft decisions should be held at agreed times during the session, for consideration and possible adoption at the last meeting of the session, on 30 November 2023. The Executive Board agreed that the Permanent Representative of Kenya and Vice-Chair of the Executive Board would chair the informal consultations, assisted by the Deputy Permanent Representative of Portugal.

A representative of the secretariat gave a presentation providing further detail, including on the World Smart Cities Outlook study, the consultation process and the expert working groups. The representative of the secretariat also expressed gratitude to the Government of France for contributing \$300,000 for the preparatory process.
- 59. Introducing the item, the Chair drew attention to the report of the Executive Director on normative and operational activities of UN-Habitat, including an update on Sustainable Development Goal Cities (SDG Cities), the Sustainable Urban Resilience for the Next Generation (SURGe) initiative and activities for the period January–June 2023 (HSP/EB.2023/17), and an annex to that report presenting highlights of normative and operational activities for the period January–June 2023 (HSP/EB.2023/INF/7).
- 63. The Executive Director delivered a statement presenting selected highlights of the report on progress made in the development and implementation of normative and operational activities. Representatives of the secretariat gave a presentation providing further information on the SDG Cities flagship programme and the SURGe initiative. Gino Van Begin, Secretary-General of ICLEI Local Governments for Sustainability, delivered a statement via recorded video message on the potential of SURGe to accelerate multilevel climate action by connecting subnational commitments to national and multilateral networking. Wael Nasr Attiya, Permanent Representative of Egypt to UN-Habitat, provided, on behalf of the Egyptian Ministry of Foreign Affairs, a testimony on the value of collaborating with UN-Habitat within the framework of the SURGe initiative.

- 64. - 65. The representatives of Israel, Saudi Arabia and the United States spoke in exercise of the right of reply.
- 66. The Executive Board took note of the documentation presented under agenda item 11 and the further information provided.
- 67. The Executive Board adopted part (a), on implementation of the normative and operational activities of UN-Habitat, of decision 2023/5, on implementation of the normative and operational activities of UN-Habitat; reporting on the programmatic activities of the Programme in 2022; implementation of subprogrammes, flagship programmes and technical cooperation activities. The decision is set out in document HSP/EB.2023/23.

### XII. Preparations for the twelfth session of the World Urban Forum

- 68. Introducing the item, the Chair drew attention to the report of the Executive Director on the status of preparations for the twelfth session of the World Urban Forum (HSP/EB.2023/18).
- 69. The Executive Director provided an update on the preparations by UN-Habitat for the twelfth session of the World Urban Forum, to be held in Cairo from 4 to 8 November 2024. Representatives of the secretariat provided further detail on the preparations, including on the design and development of the programme for the twelfth session, engagement opportunities for Member States and partners, and the new cycle of the World Urban Forum. The representative of Egypt gave a statement on behalf of the Government of Egypt presenting the arrangements for the session.
- 70. Following the statement and presentation, statements were made by the following States members of the Executive Board: Argentina, Egypt, Germany, Kenya, Nigeria and United States.
- 71. The Executive Board took note of the documentation presented under agenda item 12 and the further information provided.
- 72. The Executive Board adopted part (c), on the twelfth session of the World Urban Forum, of decision 2023/5, on implementation of the normative and operational activities of UN-Habitat; reporting on the programmatic activities of the Programme in 2022; implementation of subprogrammes, flagship programmes and technical cooperation activities. The decision is set out in document HSP/EB.2023/23.

# XIII. Discussion on the implementation of the United Nations development system reform in UN-Habitat: review of the checklist for governing bodies of United Nations Sustainable Development Group entities

- 73. Introducing the item, the Chair drew attention to a note by the secretariat on the implementation by UN-Habitat of the reform of the United Nations development system (HSP/EB.2023/19) and a checklist for the consideration of the governing bodies of the United Nations Sustainable Development Group entities (HSP/EB.2023/INF.8).
- 74. The Executive Director delivered a statement on the contribution of UN-Habitat to the implementation of General Assembly resolution 72/279 on the reform of the United Nations development system. A representative of the secretariat gave a presentation providing further information on the matter. Ghulam Mohammad Isaczai, Deputy Special Representative of the Secretary-General and Resident and Humanitarian Coordinator for Iraq, delivered a statement via recorded video message on the role of UN-Habitat in reconstruction in conflict-affected urban areas, including Iraq, in the context of the reform of the United Nations development system.
- 75. Following the statement and presentation, statements were made by following States members of the Executive Board: Senegal, Sweden and United States.
- 76. The Executive Board adopted part (f), on the checklist on the implementation of the reform of the United Nations development system, of decision 2023/4, on financial, budgetary and

## XIV. Report of the Office of Internal Oversight Services to the Executive Board

- 77. Introducing the item, the Chair drew attention to the summary of the report of the Office of Internal Oversight Services to the Executive Board, as set out in the relevant note by the secretariat (HSP/EB.2023/20).
- 78. The Executive Director delivered a statement on the report of the Office of Internal Oversight Services to the Executive Board and welcomed Fatoumata Ndiaye, Under-Secretary-General for Internal Oversight Services, who delivered a statement on the activities of the Office of Internal Oversight Services for the period 1 July 2022 to 30 June 2023.
- 79. Following the statements, the Chair highlighted the work carried out by the Executive Director and her team to implement the recommendations of the Office of Internal Oversight Services.
- 80. A statement was made by the representative of the following State member of the Executive Board: United States. The Executive Director and the Under-Secretary-General responded to the issues raised.
- 81. The Executive Board took note of the documentation presented under agenda item 14 and the further information provided.
- 82. The Executive Board adopted paragraph 5 of part (b), on the report of the Joint Inspection Unit on the findings of its review of the management and administration of UN-Habitat, the report of the Office of Internal Oversight Services and the report of the Ethics Office, of decision 2023/4, on financial, budgetary and administrative matters of the United Nations Human Settlements Programme (UN-Habitat); implementation of the recommendations of the Joint Inspection Unit based on the findings of its review of the management and administration of UN-Habitat; and draft work programme and budget for 2024. The decision is set out in document HSP/EB.2023/23.

### XV. Report of the Ethics Office to the Executive Board

- 83. Introducing the item, the Chair drew attention to the summary of the report of the Ethics Office to the Executive Board, as set out in the relevant note by the secretariat (HSP/EB.2023/20).
- 84. The Executive Director submitted to the Executive Board for its consideration the report of the Ethics Office, and gave a statement on the work being carried out by UN-Habitat to ensure the application of the ethical standards of the United Nations. A representative of the secretariat delivered a presentation providing further detail, including on outreach and training activities, and ethics-related and conduct-related cases and complaints.
- 85. Following the submission of the report and the delivery of the statements, a statement was made by the representative of the following State member of the Executive Board: United States. The Executive Director and a representative of the secretariat responded to the issues raised.
- 86. The Executive Board took note of the documentation presented under agenda item 15 and the further information provided.
- 87. The Executive Board adopted paragraph 6 of part (b), on the report of the Joint Inspection Unit on the findings of its review of the management and administration of UN-Habitat, the report of the Office of Internal Oversight Services and the report of the Ethics Office, of decision 2023/4, on financial, budgetary and administrative matters of the United Nations Human Settlements Programme (UN-Habitat); implementation of the recommendations of the Joint Inspection Unit based on the findings of its review of the management and administration of UN-Habitat; and draft work programme and budget for 2024. The decision is set out in document HSP/EB.2023/23.

# XVI. Progress in the implementation of the recommendations of the 2022 report of the Joint Inspection Unit on the findings of its review of the management and administration of UN-Habitat

- 88. Introducing the item, the Chair drew attention to the report of the Executive Director on progress in the implementation of the recommendations of the 2022 report of the Joint Inspection Unit on the findings of its review of the management and administration of UN-Habitat (HSP/EB.2023/21).
- 89. The Executive Director delivered a statement on progress in the implementation of the recommendations of the Joint Inspection Unit. A representative of the secretariat gave a presentation providing further information on the matter.
- 90. Following the statement and presentation, statements were made by the representatives of the following States members of the Executive Board: Brazil, China, Colombia, France and United States. The Executive Director and a representative of the secretariat responded to the issues raised.
- 91. The Executive Board considered the upcoming assessment by the Multilateral Organization Performance Assessment Network (MOPAN), which would help guide the development of the strategic plan of UN-Habitat for the period 2026–2029. Suzanne Steensen, Head of the secretariat, MOPAN, delivered a statement via recorded video message. The representative of Spain delivered a statement on behalf of Germany and Spain, the institutional leads for the assessment.
- 92. The representative of Spain delivered a national statement.
- 93. The Executive Board took note of the documentation presented under agenda item 16 and the further information provided.
- 94. The Executive Board adopted paragraphs 3 and 4 of part (b), on the report of the Joint Inspection Unit on the findings of its review of the management and administration of UN-Habitat, the report of the Office of Internal Oversight Services and the report of the Ethics Office, of decision 2023/4, on financial, budgetary and administrative matters of the United Nations Human Settlements Programme (UN-Habitat); implementation of the recommendations of the Joint Inspection Unit based on the findings of its review of the management and administration of UN-Habitat; and draft work programme and budget for 2024. The decision is set out in document HSP/EB.2023/23.

## XVII. Consideration and adoption of the outcomes of the session, including the provisional agenda for the first session of 2024

- (b) Decision 2023/5: Implementation of the normative and operational activities of UN-Habitat; reporting on the programmatic activities of the Programme in 2022; implementation of subprogrammes, flagship programmes and technical cooperation activities, comprising:
  - (i) Part (a): Implementation of the normative and operational activities of UN-Habitat;
  - (ii) Part (b): Analysis of the principal obstacles to the implementation of the New Urban Agenda;
  - (iii) Part (c): Twelfth session of the World Urban Forum;
- (c) Decision 2023/6: Implementation of the outcomes of the second session of the UN-Habitat Assembly, including preparation of the strategic plan for the period 2026–2029;
- (d) Decision 2023/7: Methods of work of the Executive Board and the workplan of the Executive Board for 2024, comprising:
  - (i) Part (a): Reports of the Executive Board and its working groups;
  - (ii) Part (b): Working methods of the Executive Board to improve the efficiency and effectiveness of sessions of the Board;
  - (iii) Part (c): Date and agenda for the next session of the Executive Board and its workplan for 2024.

#### B. Dates and provisional agenda for the next session of the Executive Board

96. The Executive Board adopted part (c), on date and agenda for the next session of the Executive Board and its workplan for 2024, of decision 2023/7, on methods of work of the Executive Board and the workplan of the Executive Board for 2024. The decision is set out in document HSP/EB.2023/23.

### XVIII. Officers of the Executive Board

### A. Rotation of the Chair and Rapporteur of the Executive Board

- 97. In accordance with paragraph 3 of rule 9 of the rules of procedure of the Executive Board, which requires that the offices of Chair and Rapporteur are to rotate each year to a different regional group, the Chair confirmed that it was the turn of the regional group of the African States, as the only regional group not having held the position since the entry into force in 2019 of the new governance structure of UN-Habitat, to chair the Executive Board. The Chair also confirmed that it was the turn of the regional group of the Asia-Pacific States to hold the position of Rapporteur.
- 98. Accordingly, and noting the decision of the Executive Board at its second session of 2023, held on 8 June 2023, to extend the terms of office of the current Bureau members until the closure of the resumed second session of the UN-Habitat Assembly, in 2025, the Executive Board confirmed the rotation of the officers of the Bureau of the Executive Board to serve from the closure of the third session of 2023, for the period 2023–2024, as follows:

Chair: African States (subject to any change in their representative to the Bureau)

Vice-Chairs: Brazil

France

Poland

Rapporteur: Pakistan

### B. Election of the chairs and co-chairs of the ad hoc working groups of the Executive Board

- 99. The Executive Board elected Colombia as Chair and Nigeria as Co-Chair of the ad hoc working group on programmatic, budgetary and administrative matters, and elected Portugal as Chair of the ad hoc working group on the development of a stakeholder engagement policy.
- 100. The Executive Board adopted paragraphs 7 and 8 of part (a), on reports of the Executive Board and its working groups, of decision 2023/7, on methods of work of the Executive Board and the workplan of the Executive Board for 2024. The decision is set out in document HSP/EB.2023/23.

### XIX. Other matters

- 101. Under the item, the Executive Board discussed the development of a stakeholder engagement policy, including concern at the exclusion of two organizations from the second session of the UN-Habitat Assembly in June 2023; and the imminent departure of the Executive Director upon conclusion of her term of office.
- 102. Statements were made on those matters by the representatives of the following States members of the Executive Board: Angola, Argentina, Colombia, Egypt, Germany, Kenya, Morocco, Nigeria, Türkiye and United States. Statements were also made by the representatives of the European Union, Netherlands (Kingdom of the) and the State of Palestine.
- 103. Members States took note with appreciation of the end of the term of the Executive Director on 19 January 2024. Statements delivered by Member States during the session are available under the "Statements" tab at: https://unhabitat.org/meetings/third-session-of-2023-of-the-executive-board.
- 104. The Executive Director announced that Azerbaijan would host the thirteenth session of the World Urban Forum in Baku in 2026. The representative of Azerbaijan made a statement on the matter.

### **XX.** Closure of the session

- 105. The Executive Director of UN-Habitat delivered a closing statement.
- 106. The Chair declared the session closed at 7.20 p.m. on Thursday, 30 November 2023.
