#### **SLIDE 4:** Item 2a: Revised provisional Agenda.

Excellencies,

Let me now share our update on agenda item 2 which is Preparations of the third open-ended meeting of the Committee of Permanent Representatives (OECPR) in 2025.

I will specifically highlight the latest version of the provisional Agenda and the proposed organization of work based on previous discussion by this Bureau at its last meeting held on 5 July. I will then also share the expected composition of the next Bureau of the CPR in anticipation of the elections which is scheduled to take place during the third OECPR meeting.

Mr. Chairman,

It is my understating that the Bureau had discussed the dates of the third OECRP and suggested that the meeting be held from 26 to 28 May 2025, just prior to the second session of the UN-Habitat Assembly.

It is also my understanding that Bureau at its meetings of 21 June and 5 July gave inputs with respect to the provisional Agenda for the third OECPR, and that today, the intention is for the Bureau to make a final recommendation on the agenda to enable us proceed with preparation of the necessary documents towards the meeting, including my Notification to Members and partners.

The latest version of the provisional Agenda is now on the screen. This version has taken into account the adjustments requested during the meeting of 5 July and is as follows:

A key change that was proposed at the meeting of 5 July is on agenda item 8 wherein the Bureau Members recommended that the words "Preparation of draft resolutions, declarations and decisions' be changed to "Draft Outcomes". This is highlighted in blue as you can see. This was primarily meant to discourage the possibility of submission of new resolutions and maintaining outcomes that are based only on the need to conclude the unfinished business of the second session of the UN-Habitat Assembly.



# SLIDE 7: item 2b. Proposed organizational arrangements <u>prior</u> to the third OECPR

Mr. Chairman

Excellencies,

Let me now move to subitem 2b which is the Proposed organization of work for the third OECPR.

It is my understanding that the Bureau had begun looking at the proposed organization of work in order to better understand how the items in the provisional agenda could be efficiently covered during the meeting.

I now have the pleasure to share the latest version of the organisation of work based on recommendations from the preliminary discussions held on 5 July 2024.

The proposed organisation of work is reflected on the screen and is available in front of you.

Prior to the third OECPR, and in addition to the **Bureau meetings** which can be expected to be quite regular especially from January 2025, we wish to propose that **informal consultations be held at least from February 2025** to begin discussions on the various elements of the agenda items before the OECPR.

Specifically, any draft decisions and resolutions that the UN-Habitat Assembly should eventually consider at its resumed second session should first go through the **informal consultations** prior to the OECPR and benefit from final consultations and recommendation to the Assembly during the OECPR.



Allow me to emphasize here that the expectation we all have is that there will be a very limited number of draft decisions and resolutions to be considered. The intention during the OECPR and subsequently the resumed session of the Assembly is to conclude only the unfinished business emanating from the adjourned second session of the Assembly.

# SLIDE 8: item 2b. Proposed organizational arrangements during the third OECPR

Excellencies,

Coming to the organization of work during the third OECPR itself, this is what we wish to share based on your preliminary guidance on 5 July 2024 and as reflected on the screen.

On Day 1 of the OECPR, at the morning plenary we propose that the following items be considered by the OECPR:

### Agenda item 1: Opening of the meeting:

- a) Organizational matters;
- b) Adoption of the agenda and the workplan for the third open-ended meeting of the Committee of Permanent Representatives.

**Agenda item 2:** Adoption of the report of the Committee of Permanent Representatives on the work of its second open-ended meeting.



• In addition, we propose that the Chairs of Regional Groups be given the space to make Regional Statements as was done during the first and second open-ended OECPR meetings in 2021 and 2023.

**Agenda item 3:** Progress in the implementation of the New Urban Agenda: a) Briefing on the preparation of the quadrennial report of the Secretary-General on progress in the implementation of the New Urban Agenda.

**During Lunch break on day 1**, we hope that informal consultations on draft decisions and resolutions can continue.

In the Afternoon of Day 1, we propose that focus be placed on the following two agenda items as suggested by the Bureau at its meeting on 5 July 2024:

**Agenda item 4:** Report of the twelfth session of the World Urban Forum and preparations for the thirteenth session of the World Urban Forum.

**Agenda item 5:** Progress in the implementation of the decisions and resolutions adopted by the United Nations Habitat Assembly at its adjourned second session.

• In the evening of Day 1, following the end of interpretation services, informal consultations on draft decisions and resolutions may continue

<u>In the morning of Day 2</u>, we propose that focus be placed on the following two agenda items:

**Agenda item 6:** Strategic plan of the United Nations Human Settlements Programme: with the sub-items:



- a) Implementation of the strategic plan for the period 2020–2025, including its midterm review;
- b) Status of preparation of the strategic plan for the next period 2026 -2029 by the Executive Board.

**Agenda item 7**: Review of the status of preparations for the resumed second session of the United Nations Habitat Assembly.

 Again informal consultations can continue during Lunch break of Day 2

<u>From the Afternoon of Day 2 all through to the morning of Day 3</u>, we propose that ample focus be given to this very important agenda item in preparation for the resumed second session of the Assembly which is

**Agenda item 8:** Preparation of draft outcomes of the resumed second session of the United Nations Habitat Assembly, including the dates and provisional agenda of the third session.

Agenda Item 8 will usher in the final informal and formal consultations on draft decisions until they are in good shape for recommendation to the Assembly by the **end of the Morning of Day 3.** 

Agenda item 8 is therefore proposed to remain as the focus of Day 3, in the morning and early part of the afternoon, should that be required.

The final plenary of the OECPR in the afternoon of Day 3 will conclude with the following items:
