



Third open-ended meeting of the Committee of Permanent Representatives (OECPR), 26 - 28 May 2025 Proposed Organization of work¹

A. Proposed organizational arrangements prior to the third OECPR

1. **CPR Bureau meetings** would be held regularly from January 2025 to guide the preparations for the third OECPR.
2. **Informal consultations** are to be held from February 2025 to begin discussions on the various elements of the provisional Agenda of the third OECPR, particularly the draft outcomes that the United Nations Habitat Assembly (UN-Habitat Assembly) should eventually consider at its resumed second session, taking into account the following:
 - a. In the absence of a CPR Subcommittee, the draft outcomes are proposed to first go through the informal consultations prior to the OECPR and benefit from final consultations and recommendation to the UN-Habitat Assembly during the third OECPR. This practice was established and successfully used prior to the second OECPR meeting in 2023 to facilitate the advance discussions on draft outcomes under the leadership of the CPR Chair.
 - b. It is expected that there will be a very limited number of draft outcomes to be considered by the UN-Habitat Assembly at its resumed second session and that those draft outcomes are for purposes of concluding the unfinished business emanating from its adjourned second session.

B. Proposed organizational arrangements during the third OECPR

The overview of the proposed organizational arrangements during the third OECPR is presented below.
