### Item 1

## Opening of the session

- 1. The Executive Board of the United Nations Human Settlements Programme (UN-Habitat) held its first session of 2024 from 6 to 8 May 2024 at the UN-Habitat headquarters in Nairobi. The report of the Executive Board on its work at that session is set out in document HSP/EB.2024/12, while the decisions adopted by the Board at that session are set out in document HSP/EB.2024/13.
- 2. In decision 2024/4, adopted at its first session of 2024, the Executive Board decided that its second session of 2024 would be held for a duration of three days from 4 to 6 December 2024. The provisional agenda of the second session of 2024, as agreed upon by the Board in its decision 2024/4 and further considered and recommended by the Bureau at its meeting on 2 September 2024, is set out in document HSP/EB.2024/14.
- 3. Under item 1 of the provisional agenda, the Chair will declare the second session of 2024 of the Executive Board open and outline the procedures for the session.
