The Executive Board

(a) **Financial, budgetary and administrative matters of UN-Habitat, including financial status of the United Nations Human Settlements Programme and the Sustainable Cities and Communities Foundation**

1. *Takes note* of the reports and updates of the Executive Director on:
 - the interim financial status of UN-Habitat as at 31 December 2024¹;
 - the staffing of the United Nations Human Settlements Programme as at 31 December 2024²;
 - recruitment, equitable geographical distribution and gender parity³; [Reserve on gender parity, RUS](#)
 - the status of the implementation of the recommendations of the report of the Board of Auditors⁴;
 - the Sustainable Cities and Communities Foundation⁵.

2. *Requests* the Executive Director to continue the efforts to strengthen non-earmarked and earmarked funding in accordance with the resource mobilization strategy, and *invites* all member states in a position to do so to contribute to UN-Habitat's core financial resources, which is indispensable to successfully fulfil its mandate and implement its strategic plan and programme of work to promote socially and environmentally sustainable human settlements, and to organize a successful resumed second session of the UN-Habitat Assembly.

3. [\[Welcomes\] {EGY+} \[Takes note of\] \[EGY+\]](#) the presentation on the status of the implementation of the recommendations of the report of the Board of Auditors and the efforts undertaken by the Executive Director to implement these recommendations.

matters to continue its consideration of the non-earmarked budget of the United Nations Habitat and Human Settlements Foundation for the year 2026, and *requests* the Executive Director to finalize the draft annual work programme and budget for 2026 based on feedback from the Committee for Programme and Coordination and the Advisory Committee on Administrative and Budgetary Questions, and to present it to the Executive Board at its third session of 2025 for further consideration and possible approval;

The Executive Board

(a) **Implementation of the normative and operational activities of UN-Habitat**

1. *Takes note with appreciation* of the briefing and the report by the Executive Director on normative and operational activities of UN-Habitat⁸, including the way forward for enhanced capacity development across UN-Habitat programmes and *requests* the Executive Director to continue to regularly provide status reports and briefings on UN-Habitat’s efforts to assist in the reconstruction of human settlements affected by conflict and disaster.

Draft Decision 2025/C: Update on the implementation of resolutions adopted by the United Nations Habitat Assembly

The Executive Board

(a) Progress in the implementation of all resolutions adopted by the UN-Habitat Assembly

1. Takes note of the report of the Executive Director on the implementation of resolutions adopted by the UN-Habitat Assembly.⁹

2. Recalls resolution 2/1 of the UN-Habitat Assembly, takes note of the draft international guidelines on people-centred smart cities¹⁰ and the related report on progress by the Executive Director [~~and recommends that the draft be submitted to the resumed second session of the UN Habitat Assembly for further consideration and possible adoption~~] {COL+, EGY+, MAR+, MEX-}.

3. Recalls resolution 2/7 of the UN-Habitat Assembly, [~~welcomes~~] {CRI+, DZA+, MEX-} [~~takes note of~~] {CRI+, DZA+, MEX-} the outcome of the first session of the Open-Ended Intergovernmental Expert Working Group on Adequate Housing for All held from 9 to 11 December 2024, and decides that, subject to the provision of sufficient additional financial resources, the second session of the Open-Ended Intergovernmental Expert Working Group on Adequate Housing for All will be held for a duration of three days [in the [~~third~~ ~~or~~] {Chair+} fourth quarter of 2025.

4. Recommends that the provisional agenda for the second session will be prepared by the co-Chairs of the Open-Ended Intergovernmental Expert Working Group on Adequate Housing for All, and shared with all Member States at least six weeks in advance of the meeting. {Secretariat to review text as requested by Chair}

The Executive Board

(a) **Reports of the Executive Board and its working groups**

1. Adopts the report of the Executive Board of the UN-Habitat on the work of its second session of 2024¹¹;

[1bis [*decides*] {NGA+} [*recommends*] {NGA+}, following internal consultations and information provided by the Secretariat on legal and practical considerations pertaining to implementation of Rule 9 (3) of its rules of procedure, that any decision on the rotation of the office of Chair and Rapporteur shall be taken at the end of the first regular session of the Executive Board each year.] {BRA+} {Reserve, EGY, NGA, MAR}
