## AGENDA ITEM 2: STATUS OF PREPARATIONS OF THE THIRD OECPR AND THE RESUMED SECOND SESSION OF THE UN-HABITAT ASSEMBLY

- **Pre-session documents** for the third OECPR and the resumed second session of the UN-Habitat **Assembly** have been made available on **14 April 2025** and **17 April 2025** respectively in line with the rules of procedure of the Assembly.
- The **concept note** for the **high-level dialogue** under agenda item 6 on the next strategic plan of UN-Habitat with a focus on “Adequate housing for all, has been made available for Member States. The dialogue to be held on **29 May 2025** in the afternoon from 3pm to 6pm. Delegations to register to speak at the dialogue.
- The opening of the resumed second session of the Assembly on **29 May at 10 am** will include opening statements from the UN-Habitat Executive Director, the UNEP Executive Director, UNON Director-General, the President of the General Assembly, the President of the 2025 session of ECOSOC and the Host country.

  - c. Draft decision on the **dates and Provisional Agenda** for the **third session** of the United Nations Habitat Assembly
