MEETING SUMMARY

Agenda Item 1: Opening of the meeting

1. Hon. Enrique Ochoa, Vice Minister of Multilateral Affairs and Human Rights of Mexico, on behalf of Honourable Edna Elena Vega Rangel, Secretary of Agrarian, Territorial and Urban Development of United Mexican States and President of the UN-Habitat Assembly, opened the meeting at 16:30 EAT.

- 2. The President welcomed all participants to the meeting. The Agenda was adopted without any changes and can be accessed here.
- 3. The Executive Director delivered her opening remarks. The presentation by the secretariat can be accessed <u>here</u>.

Agenda item 2: Status of the draft outcomes to be considered by the OECPR and the UN-Habitat Assembly

- 4. H.E. Mr. Pedro Leon Cortes Ruiz, Ambassador of the Republic of Colombia and Permanent Representative to UN-Habitat reported on the status of the draft outcomes to be considered by the OECPR and the UN-Habitat Assembly. He highlighted that while some progress has been made, but that significant efforts will be needed to achieve consensus on several fronts.
- 5. The President of the Assembly highlighted the importance of the adoption of the strategic plan 2026-2029 and encouraged the members to continue to make every effort to bring consensus.
- 6. Mr. António Miguel, Deputy Permanent Representative of the Republic of Portugal to UN-Habitat, in his capacity as Chair of the ad hoc working group on the development of a stakeholder engagement policy, provided a progress update on status of the document, whereby he informed the Bureaux that four members of the Executive Board had broken the silence procedure. Mr. Miguel put forward two possible options for the next steps: 1) to simply take note of the status of lack of consensus at the Assembly, and 2) to prepare a significantly different draft proposal regarding the outstanding issue and launch a new silent procedure before it is presented to the Assembly.
- 7. The Members of the Joint Bureax exchanged views on the matter and recalled that this matter rests within the Executive Board. Acknowledging the breaking of the silence procedure, the members of the Executive Board bureau decided to report to the Assembly of the absence of consensus on the stakeholder engagement policy.
- 8. The Joint Bureaus took note of the status of the draft outcomes to be considered by the OECPR and the UN-Habitat Assembly.

Agenda item 3: Review of the latest programme of the third OECPR and the resumed second session of the Assembly including special events

- 9. The secretariat presented the latest programme of the third OECPR and the resumed second session of the Assembly including special events. The programme can be accessed here.
- 10. One member of the Bureau of Assembly suggested that the planned briefing on elections on 26 may lunch time should also cover voting on substantive matters. The secretariat confirmed that the briefing will cover voting both in elections and on substantive matters.
- 11. The Chair of the Executive Board delivered a statement on the preparations for the 2025 second session of the Executive Board and requested the secretariat to prepare a draft decision on the outcome of the session. The statement can be accessed here.
- 12. The Bureau took note of the latest programme of the third OECPR and the resumed second session of the Assembly including special events, as presented by the secretariat, and of the plans for the second meeting of the Executive Board 2025, as presented by the Chair of the Executive Board.

Agenda item 4: Update on registration, high level participation, credentials and nominations towards elections

- 13. The secretariat provided an update on registration, high level participation, credentials and nominations towards elections.
- 14. The Joint Bureaux took note of the update.

Agenda item 5: Division of work among the Bureau Members during the session

- 15. The President noted the possible need to establish a Committee of the Whole during the resumed second session of the UN-Habitat Assembly on 29 and 30 May to seek agreement on any outstanding issue that remains from the OECPR deliberations. He proposed that H.E. Mr. Damptey Bediako Asare, High Commissioner of Ghana and Permanent Representative to UN-Habitat, Vice-President of UN-Habitat Assembly well assume the role of chair of the Committee of the Whole, who may immediately convene a plenary meeting of the Committee on Day 1 of the Assembly, to agree on an agenda and work programme, and to establish a drafting group for negotiations.
- 16. The President also noted that, if established, the second and final plenary meeting of the Committee of the Whole will be held at the end of the morning session of the third Assembly plenary on 30 May, to finalize the work of the Committee, and that the Chair of the Committee will report back on its work at the closing plenary of the Assembly, as a basis for the Assembly to take action on the draft decisions.
- 17. The Bureau agreed with proposal of the President of the Assembly for the division of labour among the Bureau Members during the resumed second session of the UN-Habitat Assembly, including with regard to the nomination of Ghana as Chair of the Committee of the Whole.

Agenda item 6: Any other matters

- 18. No matters were raised.
- 19. The meeting was adjourned at 18:30 EAT.
