Introduction

Adequate Housing at the centre of UN-Habitat mandate since its establishment

Housing crisis: 2.8 billion people live in inadequate housing, including 1.1 billion people who live in slums or informal settlements and over 300 million are experiencing homelessness.

UN-Habitat Assembly Resolution 2/7: Adequate Housing for All - establishing of OEWG on (OEWG-H) and a Knowledge Platform on Housing & Resolution 2/2: Accelerating the transformation of informal settlements and slums by 2030

Housing, land and basic services at the core of the new **UN-Habitat Strategic Plan** 2026-2029

Open Ended Intergovernmental Working Group on Adequate Housing for All (OEWG-H)

Objectives:

- Develop robust, peer-reviewed, and Member State-endorsed set of recommendations to accelerate the achievement of safe, sustainable, adequate, and affordable housing for all.
- Submit recommendations to the third United Nations Habitat Assembly in 2029.
- Use content developed and provisional recommendations to advance adequate housing policies and programmes at national and local level.

Key developments on Informal settlements definition



Expert Group Meeting on Slum Definitions (EGM, 2002): informed monitoring of MDG Target 7.D and the five deprivation criteria



Habitat III Session and Issue Paper on informal settlements (2016): Highlighted the importance of informal settlements as a key issue for the NUA and the need to have a working definition for informal settlements under SDG Target 11.1



Programmatic working definitions: UNITAC, PSUP, IADB, Cities Without Slums (CA), Global Action Plan (GAP), etc.

DEFINITION OF INFORMAL SETTLEMENTS Emerging considerations on existing definitions from the EGM

- The Expert Group Meeting on 21 August convened around 50 experts.
- Not all countries have an official definition in place; some have multiple definitions relating to various authority levels or institutions.
 - o Benefit of an international definition that can be adapted at national and subnational levels
- Stakeholders have collaborated to **create working definitions** where no official national definitions exists.
 - Opportunity to learn from existing working definitions to inform a global definition (conceptual and operational aspects e.g. data collection practices)

Definition of Informal Settlements Emerging considerations on key elements from the EGM

Features of informal settlements definition highlighted by experts:

- Combination of household- and settlement-level perspectives
- ➤ Differentiation of settlement typologies
- Recognizing positive aspects and opportunities
- > Principles of the development of a definition of informal settlements

Key Questions from the EGM:

- 1. Does your country or organisation have a definition of informal settlements? If so, which one is it? Has this been recognized by statistical offices? What are the pros and cons of such definition?
- 2. What should be key elements of the definition of informal settlements?
- 3. What data collection methodologies exist? What are the innovations needed?
