**It allows users to cross-reference meetings, documents, and agenda items and obtain comprehensive information across different search criteria.**

**It provides a snapshot overview of future and past meetings**

**e-deleGATE gives access to the latest information on the schedule of meetings, lists of proposals, draft and adopted resolutions and decisions, & documentation.**

**e-deleGATE is part of the Secretariat's response to mandates contained in General Assembly resolution [77/335](#), which calls upon its subsidiary organs to use, as much as possible, existing e-deleGATE modules and requested the Secretariat to consolidate such services.**

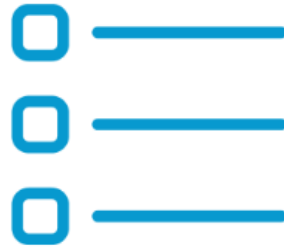
**The initiative enhances the quality and availability of information on intergovernmental bodies for Member States, observers, UN entities, civil society, and the wider public**

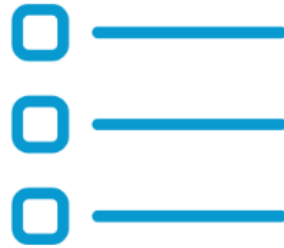
