Item 1

Opening of the session

- 1. On 9 June 2023, the United Nations Habitat Assembly (UN-Habitat Assembly), in resolution 2/7, established the Open-Ended Intergovernmental Expert Working Group on Adequate Housing for All. In the same resolution, the UN-Habitat Assembly decided that the Working Group's activities and programme of work would be determined in consultation with the Executive Board of the United Nations Human Settlements Programme (UN-Habitat). The UN-Habitat Assembly also decided that the Executive Board would decide on the timing and duration of the sessions of the Working Group.
- 2. The Working Group held its first session from 9 to 11 December 2024 in Nairobi.
- 3. The Executive Board at its first session of 2025 took note of the outcomes of the first session of the Working Group and decided that, subject to the provision of sufficient additional financial resources, the second session of the Working Group would be held for a duration of two or three days in the fourth quarter of 2025.
- 4. Subsequently, the Co-Chairs of the Working Group, in consultation with the Bureau of the Executive Board, recommended that the second session of the Working Group be held for a duration of two days, on 22 and 23 October 2025, in Nairobi.
- 5. It is expected that the second session will be opened at 9 a.m. on Wednesday, 22 October 2025.

6. Under this item, the Working Group will adopt the agenda of its second session and decide on the organization of work for the session.
