Second session of the Open-ended Intergovernmental Expert Working Group on Adequate Housing for All



1. Introduction

On 9 June 2023, the United Nations Habitat Assembly (UN-Habitat Assembly), in resolution 2/7, established the Open-Ended Intergovernmental Expert Working Group on Adequate Housing for All. In the same resolution, the UN-Habitat Assembly decided that the Working Group's activities and programme of work would be determined in consultation with the Executive Board of the United Nations Human Settlements Programme (UN-Habitat). The UN-Habitat Assembly also decided that the Executive Board would decide on the timing and duration of the sessions of the Working Group.

The Working Group held its first session from 9 to 11 December 2024 in Nairobi. The report of that session is set out in document HSP/OEWG-H.2024/8 and can be accessed here and the summary of the Chair set out in document HSP/OEWG-H.2024/9 can be accessed here. The Executive Board at its first session of 2025 took note of the outcomes of the first session of the Working Group and decided that, subject to the provision of sufficient additional financial resources, the second session of the Working Group would be held for a duration of two or three days in the fourth quarter of 2025. Subsequently, the Co-Chairs of the Working Group, in consultation with the Bureau of the Executive Board, recommended that the second session of the Working Group be held for a duration of two days, on 22 and 23 October 2025, in Nairobi.

Accordingly, the second session of the Open-ended Intergovernmental Expert Working Group on Adequate Housing for All will take place from Wednesday, 22 October to Thursday, 23 October 2025.

2. Location and modalities of Participation

The second session of the Open-ended Intergovernmental Expert Working Group on Adequate Housing for All will be held **in-person** at the UN-Habitat Headquarters in Nairobi, which is located at the United Nations Office in Nairobi (UNON). The main entrance is located on United Nations Avenue in Gigiri. Pedestrians may enter the complex through the pavilion, north of the main vehicular entrance. Private vehicles without official access decals may not enter the complex but can drop off or pick up passengers in front of the pavilion entrance.

All meetings will take place in Conference Room 2 at UNON. A weblink will be shared with duly registered delegates to allow for passive external online attendance (listen only).

Section 4 below provides more details on how to register to the meeting.

3. Travel and Electronic Travel Authorization (eTA)

A valid passport with at least six months before expiry from date of arrival, is required for entry and all delegates attending the meeting in person must obtain an Electronic Travel Authorization (eTA) to enter Kenya.

Information on the categories of eTA and how to apply is available on the website of the Kenya Electronic Travel Authorisation (eTA) application system. To obtain an eTA for Kenya, participants should follow the instruction provided on the website, including with regard to timeframes, supporting documents and requirements to upload a copy of the passport etc. It is highly recommended that travellers apply as soon as they have booked their accommodation and transport tickets.

Please note that eTA for entering Kenya and registration for attending the Working Group session are two separate procedures, and that successful registration to the Working Group does not guarantee issuance of an eTA.

Please also note that obtaining an eTA is the sole responsibility of meeting participants and not of the Secretariat.

i. Accommodation in Nairobi

Participants are requested to make own hotel reservations for their stay in Nairobi. A list of hotels recommended by the UN Office in Nairobi with suggested rates in Nairobi can be found here.

Participants who choose to use other forms of accommodation are advised to be vigilant about selecting safe and appropriate accommodation.

4. Registration for the Second session of the Open-ended Intergovernmental Expert Working Group on Adequate Housing for All

On-line registration for the session opened in June 2025 and will close on **Friday, 17 October 2025 at 12:00 (UTC + 03:00),** through UN-Habitat's Global Events Management System (UN-Habitat GEMS) registration portal, at this link.

Online registration is open to national experts nominated by Member States, Member State representatives, including from Permanent and Observer Missions, intergovernmental organizations (IGO), and non-governmental organizations in consultative status with the United Nations Economic and Social Council (ECOSOC) or accredited to the United Nations Habitat Assembly (UN-Habitat Assembly).

i. Member States and IGO delegates

Member States and IGO delegates are required to upload a formal notification/ note verbale reflecting the names of the representative(s) as part of the official delegation when registering. ii. Non-governmental organizations

The session is only open to accredited major groups and other stakeholders. Stakeholders in consultative status with ECOSOC or accredited to the UN-Habitat Assembly may register, in line with Rules 68 and 69 of the Rules of Procedure of the Assembly, which apply, mutatis mutandis, to the meeting.

- 5. Each accredited NGO may nominate **up two** representatives.
- 6. A signed nomination letter addressed to the Executive Director of UN-Habitat using an official letterhead of the organization they represent must be uploaded to the registration portal as part of the online registration

iii. Media Accreditation

Participants who wish to be accredited as Media representatives need to register online via this link and upload the following documents.

- A recognized national or international press association card or press pass with validity beyond the date of the Working Group session.
- A corresponding national identification card or passport.

You will be informed via email of your final accreditation status before **Friday, 17 October 2025** or contacted earlier if more information is required.

Please note that it is essential that UN-Habitat receives the requested documentation via the online registration portal at this link before the deadline of **Friday, 17 October 2025 at 12:00 (UTC +03:00)** and with the details indicated above to be able to proceed with your registration.

iv. Additional information regarding online registration

All delegates are encouraged to register online using the UN-Habitat's Global Events Management System (UN-Habitat GEMS).

Prior to registering for the Working Group, all delegates will need to first sign up or login to their existing user account on UN-Habitat's GEMS platform.

After registration, all delegates will receive first an automated e-mail confirming receipt of their registration for the second session of the Open-ended Intergovernmental Expert Working Group on Adequate Housing for All. If approved, a second e-mail notification will then be sent, with a unique confirmation number and QR code which will be used to finalize the registration process when arriving at the United Nations Office at Nairobi, for collection of the photo badge and access to the meeting rooms.

Please note that the review and verification process of online registrations may take several days, depending on the number of registrations received.

The online registration must be complete, including relevant contact details, exact title and designation etc, to enable the Secretariat to review and approve registrants.

Online registration is mandatory and will close on Friday, 17 October 2025 at 12:00 (UTC + 03:00).

All Member State delegates, including delegates posted in Nairobi that may already have a UN ground pass, must register online to the meeting and be issued with meetings-specific badges, to allow easy access to all areas and ensure the issuance of correct list of participants.

v. On-site registration

After receiving the second e-mail notification with a unique confirmation number and QR code, delegates and entities participating as observers, as well as non-governmental organization and media representatives, are welcome to collect their badges at UNON, Pass & ID office (entrance via Visitors Pavilion) on the following dates and opening hours:

- Tuesday, 21 October 2025 from 08:00 to 16:00, East Africa Time (UTC + 03:00).
- Wednesday, 22 October 2025 from 08:00 to 12:00, East Africa Time (UTC + 03:00)

vi. Change in registration details

In case of any changes to the registration details by any participant, the UN-Habitat GEMS enables participants to make changes to their user account and event registration details until the deadline **on Friday, 17 October 2025.**
