(b) Implementation of the strategic plan of UN-Habitat for the period 2020 to 2025

Requests the Executive Director to keep Member States updated on the structure and division of responsibilities for the implementation of the Strategic Plan for the period 2026–2029, recalling that ensuring an equitable balance between the normative and operational activities of UN-Habitat is essential for carrying out its mandate, in accordance with General Assembly resolution 77/173; Agreed ad ref 17 Nov PM
- 8. *Requests* the Executive Director to inform Member States, in a timely manner, on the implications of the UN80 initiative for the structure, staffing, budgetary planning and work of UN-Habitat; <u>Agreed ad ref 25 Nov 1PM</u>
- [9. Takes note of the report of the Executive Director on the update of the scalability model [and requests the Executive Director to recommend a modified scalability model that best meets the needs of the Strategic Plan 2026 2029]{NGA+} [.and decides to discontinue its use, while continuing to emphasize strategic coherence, simplification, forward planning and prioritization on the budgeting for following years in consultation with the Executive Board]{EGY+, NGA+,};]

The Executive Board

- 1. Takes note of the update and report by the Executive Director on normative and operational activities of UN-Habitat including updates on the Nigeria Country Programme, the Philippines Country Programme, trends and innovations in cooperation with local and regional governments, initiatives on urban crises prevention and response and highlights of activities for the period from January to June 2025 and requests the Executive Director to continue to provide regular status reports and briefings on the efforts of UN-Habitat to assist in the reconstruction of human settlements affected by conflict and disaster; Agreed ad ref 17 Nov PM

- 3. Takes note of the report on the status of the development of the efforts to reconstruct the human settlements in the Gaza Strip⁸ and requests UN-Habitat to finalize the comprehensive report, based on field-based assessments if conditions allow, and present the report at the first Executive Board of 2026; Agreed ad ref 17 Nov PM

Requests the Executive Director to continue providing timely updates to the Executive Board on country level implementation, regional engagement, partnerships with local authorities, and programme work on urban crisis prevention and response, ensuring coherence with the Strategic Plan 2026-2029;]
