UN-Habitat in Spain is composed of a Liaison Office in Madrid and two Programme Offices in Barcelona: the GWOPA¹ Secretariat (Global Water Operator Partnerships Alliances) and the CRPP² Office (City Resilience Profiling Programme). The role of the Office located in Madrid is to act as a liaison with the Spanish government and the New Urban Agenda partners in Spain, adding value to UN-Habitat's work in selected areas of collaboration.

The UN-Habitat Office in Spain (Madrid) also supports the monitoring of all initiatives supported by Spanish partners and the implementation of UN-Habitat's mandate through advocacy, effective knowledge, strategic partnerships and resource mobilization, technical support and outreach and communication on sustainable urban development.

Based on the foregoing, this Office:

»Promotes and keeps institutional representation and liaison with the Spanish partners and other New Urban Agenda partners in Spain.

»Fosters knowledge, advocacy and visibility of the New Urban Agenda and UN-Habitat priority areas.

# PROJECT "PROMOTING SUSTAINABLE URBAN DEVELOPMENT: TOWARDS A NEW URBAN AGENDA"10

EGM "Elaboration of the Quadrennial Report: Progress on the implementation of the New Urban Agenda"<sup>11</sup> Granada, 20- 23<sup>th</sup> March

With the support of the Andalusian Agency of International Cooperation for Development (AACID), on 20, 21, 22 and 23<sup>rd</sup> March 2018, 16 UN-Habitat experts and 28 international experts in urban development from 20 countries from governments, international organizations, and academia gathered in Granada to prepare the First Quadrennial Report to monitor the implementation of The New Urban Agenda.

The Quadrennial Report tracks the progress, assesses the impact and ensures the Agenda's effective and timely implementation, and creates and reinforces partnerships while fostering exchanges of urban solutions and mutual learning. It integrates quantitative and qualitative data and information, incorporating contributions from the United Nations system and regional and sub-regional organizations. The report takes stock of the progress made and challenges faced in the implementation of the New Urban Agenda.

With the support of the Andalusian Agency of International Cooperation for Development (AACID), on 28, 29 and 30<sup>th</sup> May 2018, 33 international experts -23 from UN-Habitat- in urban development from governments, international organizations, and academia gathered in Nairobi, Kenya to produce the "Goal 11 synthesis report "under UN-Habitat's coordination.

The goal was to provide an in-depth review of the efforts and issues surrounding the implementation of urban and human settlements indicators- at local, national and global levels, sharing challenges and opportunities, and providing key recommendations for governments, civil society and the UN on the next course of action in terms of partnerships, collaborations and resource mobilization for effective implementation


